Vessels bound Sagar anchorage must report at Lower Gasper L/V (212154N,880930E) at least 2 hrs. before high water Sagar and maintain proper contact with the pilot station and VTMS all the time on Channel 16/68.</li><li>2. Master must procure estuary River Charts through their Agents for the safety of their vessels.</li><li>3. During FOUL SEASON i.e. 1st April to 31st October. Vessels barge under Inland Vessels Act are not permitted to ply below Haldia.</li><li>4. Vessels under 210mtrs. can available additional draft on Haldia Forecast basis of categories.</li><li>5. Night drafts subject to all lights in order.</li><li>6. Gasper - 6.9 mtrs. and Middleton - 6.5 mtrs.</li><li>7. Size of vessels acceptable at Virtual Jetty at Sagar between LOA 170mtrs. to 240mtrs. Minimum 16 mooring ropes would be required for berthing.</li><li>8. Pilot embarkation at Middleton Channel.</li><li>9. Vessels required to have two serviceable anchors for safe transit.</li></ol>
