TRADE CIRCULAR

Sub: Maximum utilization of PCS Messages at HDC, SMP, Kolkata.

Ref: This Office Trade Circular No. MTO/G/104/Pt. IX/1661 dated 28.05.2017.

Reference above, while Vessel Operating Agents (VOA)/Steamer Agents (SA) are registering their vessel related information through PCS and subsequently Vessel Calling Number (VCN) is allotted by the Port through PCS only, it has also been observed that on several instances, other messages / information pertaining to vessels / cargo are not being updated in the PCS modules by the concerned agencies.

It is hereby emphasized that all Vessel Operating Agents / Steamer Agents / MLOs must mandatorily update the following PCS messages as and where applicable to ensure maximum interchange of relevant information pertaining to vessels / cargo with the Port through the PCS modules:

- 1. PAXLST (Passenger crew list)
- 2. PLTMEM (Pilot Memo)
- 3. IFTDGN (Dangerous Goods Notification)
- 4. Berth Management (BERMAN)
- 5. Agent Delivery Order (AGDORD)
- 6. Container Advance List (COPRAR)
