**TRADE CIRCULAR**

**Sub.: Revised General Policy for deployment of Floating Cranes at Sandheads, Sagar and other anchorages within the limit of SMP, Kolkata**

**Ref: Trade Circular Nos. GMT/45/1087 dated 07.12.2021 and GMT/45/1061 dated 06.09.2021**

In partial supersession to the General Policy for deployment of Floating Cranes at Sandheads, Sagar and other Anchorages within the limit of SMP, Kolkata, which was initially notified through Trade Circular No. GMT/45/1061 dated 06.09.2021 and thereafter modified vide Trade Circular No. GMT/45/1087 dated 07.12.2021, the appropriate authority of SMPK has decided to modify some conditions of the earlier policy for deployment of Floating Cranes which is furnished below:

- a) Concerned importers / exporters or their agents / Vessels' Agent, at the time of indicating their vessel for booking of slots of Floating Cranes will have to deposit an amount of Rs. Ten (10) lakhs (instead of Rs. 7 Lakhs) through RTGS (**not through PCS**) to HDC to the following bank account with an intimation to Finance Division which will be retained as Security Deposit by HDC, SMPK. The bank account details are as follows:



Any deviation of the indicated ETA of the vessel + / - two (02) days or cancellation of vessel, the said deposit may be forfeited, if deemed necessary.

- b) Importers / exporters whose vessels adhere to their declared ETA within the indicated relaxation period, will be allotted Floating Cranes and will have the option of seeking refund of the said deposit amount or transfer the same as Security Deposit for their forthcoming vessel.

The above shall be implemented with immediate effect.
