विषय: 22.04.2024 से हल्दिया डॉक कॉम्प्लेक्स, एसएमपीके में बर्थ 17(ओ) (तत्कालीन एचओजे ॥) पर परिचालन का निलंबन। Sub: Suspension of operations at Berth 17(0) (erstwhile HOJ II) at HDC, SMPK from 22.04.2024. संदर्भ: ट्रेड सर्कुलर नंबर: टी.ओ.(Sh&CH)/10/प-11/598 दिनांक 23.03.2024 Ref: Trade Circular No: T.O.(Sh&CH)/10/Pt-II/598 dated 23.03.2024

In reference to the above-mentioned Trade Circular dated 23.03.2024, it may be noted that, in consideration of present situation, Competent Authority of HDC, SMPK has decided that the shutdown of Berth 17(0) (erstwhile HOJ II) shall begin from 22.04.2024. The shutdown will be for a total duration of 30 days and to be undertaken in three phases of 10 days each. In view of the operating convenience of Port Users, intermittent window for vessel operation to be allowed for periods varying between 3 to 4 days in between the above mentioned shutdown phases. The duration of such working window to be decided by Appropriate Authority of SMPK.

All users of HOJ-II are requested to be guided by the same and plan their vessels accordingly please. The duration of the above shutdown may increase in the event of exigency.
