The details of eligibility criteria of which are given below:-

### **Eligibility Criteria**

## Age:

Age should be 25 years or above as on November 01, 2015.

### **Essential Qualification and Experience:**

#### (i) Educational Qualification:

The candidate must have passed B. Tech in Electronics and Telecommunication Engineering or B. Tech in Electronics and Communication Engineering or equivalent, from a recognised University / Institute.

#### (ii) Working experience:

The candidate must have minimum 7 - 8 years of experience in the field of Signalling & Telecommunication and well versed with electro mechanical system and panel interlocking.

(iii) Preferably working experience in Indian Railway Signalling System or with recognized organization like RITES / RVNL, etc.

#### **General Instruction**

Interested candidates, fulfilling the above eligibility criteria and agreeable to the terms & conditions given in the enclosure, may appear for the Walk-in-Interview with an application furnishing the detailed bio-data (proforma enclosed) with one recent passport size photograph and self certified photocopies of relevant certificates / testimonials alongwith original (for verification) to be submitted at the time of aforesaid interview. Mere fulfilment of the eligibility criteria will not confer any right upon the candidate for selection. Management reserves the right to cancel the selection process without any reference to the candidates.

# Terms & Conditions of contractual engagement of Engineer (Signalling and Telecommunication)

- The candidate's engagement will be for a period of 01 (one) year and on expiry
  of the said period, the contractual engagement will be automatically terminated.
  However, on expiry of the contract, HDC, KoPT reserves the right to enter into
  a fresh contract for such period and such terms and conditions as may be
  mutually agreed upon by the parties.
- 2. The candidate will be responsible for :-
  - (i) Supervision of the maintenance work and technical support / quidance during failure / break down.
  - (ii) Validate the challan document on receipt of assets / gadgets after purchase by the maintenance contractor before installation.
  - (iii) Maintenance of log-books, test cards, history cards for track circuits, cable meggering, equipment history and inspection register.
  - (iv) Provide necessary guidance and direction for installation of S&T Gears.
  - (v) Certification of bills before final payment by HDC, etc.
- 3. The candidate will normally be entitled to a monthly compensation of Rs. 40,000/- (forty thousand only) per month.
- 4. The candidate may avail of HDC accommodation (unfurnished) at Haldia on payment of license fee / rent as applicable. Electricity charges shall have to be borne by the candidate at actuals.
- 5. The candidate may be required to work at any place / office within the jurisdiction of HDC, KoPT.
- 6. The candidate will have to work for 06 (six) days in a week and will be given a staggered weekly day of rest. He will be required to work in shifts on rotation i.e. morning, afternoon and night as per requirements. He may also be required to work in general shift duty, if situation so warrants. If situation so demands the weekly day of rest may be changed with prior intimation. In exigency of work, he may also be booked on weekly off days / holidays for which, appropriate relief may be considered, as per the discretion of the competent authority.
- 7. The candidate will be entitled to 15 days' leave in a year, (12 months from the date of engagement and proportionate in case of shorter period of engagement), which shall be availed of with prior approval. For any absence, in excess of 15 days, pro-rata deduction will be made from the consolidated remuneration.
- 8. Additionally, leave on medical grounds, to the extent of 10 days in a year (12 months from the date of engagement and proportionate in case of shorter period of engagement) on illness may be allowed without any deduction from the remuneration on the basis of certification from HDC, KoPT Medical Officer. Intimation of sickness should be reported to the Head of Division / Reporting Officer forthwith in writing together with the certificate of illness from a registered Medical Practitioner, in addition to verbal intimation over phone.

- 9. The candidate will be entitled to indoor and outdoor medical facilities as are available in the Port Hospital at Haldia for self and spouse only. However, no reimbursement for medicine / medical articles purchased from outside, diagnostic tests done outside or treatment received outside will be allowed. This restriction will not apply for treatment of any injury sustained due to accident occurred in the course of and arising out of engagement.
- 10. If the candidate is required to go on official tour outside headquarters of Haldia Dock Complex, the candidate will be entitled to TA/DA, as applicable to the regular incumbents in the post of Asstt. Manager, T.O.(Rly.) Division.
- 11. The candidate will be entitled to avail the canteen facility of HDC.
- 12. The candidate will normally report to the Sr. Dy. Manager, T.O. (Rlys.) Division, HDC or his representative authorized by him.
- 13. The candidate will be responsible for charge and care of the HDC / KoPT's money, goods and stores and all other property that may be entrusted to him and he will be accountable for the same.
- 14. The contractual engagement may be terminated by giving one months' notice from either side. However, the engagement is also terminable on 24 hours' notice for unsatisfactory performance and for any act considered to be derogatory / detrimental to the interest of HDC / KoPT.
- 15. The candidate will have to submit character / antecedent certificate in the prescribed proforma.
