CIRCULAR

Subject : Facility of direct delivery of Import FCL Container from
the yard in the Docks / Container Terminal, KDS.

In terms of this office circular of even no. dated 29.02.2012 and 15.03.2012 on the subject, last six month's performance of the agencies who have been allowed the facility for direct delivery of FCL container, either being CBEC Registered (Customs ACP) or being Port ACP Clients, has been reviewed by the competent authority.

The following agencies, as 'volume importers' are found eligible to take direct clearance of their respective Import FCL Containers,w.e.f. 01.04.2012.
