Sir,

One vacancy of General Manager (Traffic) under Haldia Dock Complex, Kolkata Port Trust in the pay scale of Rs. 51300-73000/-, is to be filled up by Absorption through Composite Method, from the officers of Major Port Trusts, fulfilling the eligibility criteria prescribed in the Recruitment Rules for the concerned post, as per the enclosed Schedule of the KoPT Employees' (Recruitment, Seniority and Promotion) Regulations, 2013 (Annexure-I). However, the eligibility criteria w.r.t the required qualifying service in the feeder cadre, will be relaxed in deserving cases, as per the Ministry of Shipping, Govt. of India's letters F.No.PR-12012/3/2009-PE.1 dated April 22, 2013 & PR-12012/3/2009-PE.1 dated March 12, 2014.

- ii) Attested photocopy of all certificates in support of educational qualification, present and past work experience in the respective post with pay scale.
- iii) No objection certificate of the Port.
- iv) Undertaking of the applicant not to withdraw, if selected.
- v) Vigilance / Administrative Clearance of the concerned Port, as per enclosed proforma (Annexure-III).
- vi) Two passport size photographs.

If any major or minor penalty has been imposed on the applicant during the last 10 years, the details of the disciplinary case leading to such penalty, alongwith necessary documents, may be sent

alongwith the application. The vigilance clearance may be furnished in the format prescribed, vide Ministry's letter No. A-12022/10/2005-P.E.I dated August 27, 2010.
