**Terms & Conditions of contractual engagement**

- I. The selected candidates will be engaged on contract basis for a period of 1 year. On expiry of the contractual assignment of 1 year from the date of joining, such contractual engagement will be automatically terminated. However, on expiry of the contract, KoPT reserves the right to enter into a fresh contract for such period and on such terms and conditions, as may be mutually agreed upon by the parties
- II. The selected candidates will be paid a fixed consolidated remuneration of Rs.30,708/-/- per month.
- III. The selected candidates will be deployed at Kolkata Dock System or at any other place depending on operational requirement of KoPT.
- IV. The selected candidates may avail of KoPT accommodation (unfurnished) on payment of license fee / rent as applicable. Electricity charges for the said quarters may be borne by them.
- V. The selected candidates will be responsible for assisting Chief engineer of a vessel to run, maintain, upkeep and repair the machineries of the vessel and other allied work, as would be assigned to him by the controlling Officer.
- VI. The selected candidates will be required to work at any place within the jurisdiction of KoPT.
- VII. The selected candidates will be required to work full time or 6 days in a week and will normally be entitled to a weekly off day. / declared National Holiday in exigency, he will be granted compensatory day of rest conveniently, in lieu thereof, and for this no other compensation, monetary or otherwise, would be granted.
- VIII. The selected candidates will be entitled to 15 days leave, which may be availed of with prior approval. For any unauthorized absence in excess of 15 days, pro-rata deduction will be made from your consolidated remuneration.
- IX. Additionally, the selected candidates will be entitled to 10 days sick leave on illness without any deduction from the remuneration on the basis of certification from KoPT Medical Officer, intimation of sickness should be reported to the Head of the Department / Reporting Officer forthwith in writing together with the certification of illness from a Registered Medical Practitioner in addition to verbal intimation over phone.
- X. The selected candidates will be entitled to Indoor & Outdoor Medical Facilities as are available in KoPT Hospital for self only. However, no reimbursement for medicine/medical articles purchased from outside, diagnostic test done outside or treatment received outside will be allowed.
- XI. The selected candidates will have to report to the Engineer Superintendent or his nominated officer.
- XII. The selected candidates will be entitled to medical benefits as available in KoPT Hospital for injury sustained due to accident in course of and out of employment.
- XIII. The selected candidates will be responsible for the charge and care of KoPT's money, goods and stores and all other property that may be entrusted on them and would be accountable for the same.
- XIV. The contractual engagement may also be terminated by giving one month's notice from either side. However, the engagement is terminable on 24 hour's notice for unsatisfactory performance and for any act considered to be derogatory /detrimental to the interest of the KoPT.
- XV. Such engagement will be subject to verification of antecedent of the candidate.
