5. PERFORMANCE HIGHLIGHTS

A. Cargo Traffic:

- In April-December 2016, KoPT handled a cargo throughput of 36.490 million tonnes (mt). Kolkata Dock System (KDS) handled 11.646 mt and Haldia Dock Complex (HDC) handled 24.844 mt. during Apr-Dec'16.
- KoPT registered growth in Apr-Dec'16 vis-a-vis Apr-Dec'15 in respect of POL (Crude), LPG, Other Liquid Cargo, Other Ore, Limestone, Fly Ash, Foodgrains (Rice & Wheat), Thermal Coal, Dolomite, Gypsum, Salt, Sugar, Machinery, Cement Clinker, Container TEUs & Tonnage, Other Cargo etc.
- Growth was recorded at KDS in Apr-Dec'16 vis-a-vis Apr-Dec'15 w.r.t. POL (Product), Other Liquid Cargo, Foodgrains (Rice & Wheat), Fly Ash, Container (TEUs and Tonnage), etc. Growth was observed at HDC in Apr-Dec'16 vis-a-vis Apr-Dec'15 for POL (Crude), LPG, Other Liquid, Other Ore, Limestone, Thermal Coal, Fly Ash, Petroleum Coke, Dolomite, Gypsum, Sugar, Machinery, Cement Clinker, Container (TEUs & Tonnage), Other Miscellaneous Cargo, etc.

B. Container Traffic:

- KoPT handled 5,68,123 TEUs in Apr-Dec'16 vis-à-vis 4,87,070 TEUs in Apr-Dec'15, registering a significant growth of 16.64% (against 3.81% growth registered by Major Ports). KoPT ranked 3rd amongst all Indian Major Ports in terms of Container traffic in Apr-Dec'16.

C. Comparative Performance:

- KoPT ranked First in terms of Coking & Other Coal / Coke handling and Second in Other Liquid Cargo handling amongst Indian Major Ports in Apr-Dec'16.

D. Ship Traffic:

- In Apr-Dec'16, KoPT handled 2514 ships– the highest among Indian Major Ports.

E. Railway Traffic:

- In Apr-Dec'16, KoPT handled rail-borne traffic of 19.03 mt (KDS – 4.33 mt, HDC – 14.7 mt). In this period, 1201 trains were received and 997 despatched at KDS; at HDC, 3047 trains received and 3043 were despatched.

F. Major Achievements:

- On 04.01.17, 1,098 TEUs of Containers was handled at HDC by the vessel MV. LILY STAR. This is a new record in a single day, which surpassed the earlier one of 968 TEUs handled on 18.11.2016 by the ship MV. TAUNG GYI STAR.
- On 21.09.16, KDS handled a record container throughput of 2714 TEUs, highest ever handled on a single day. (previous highest - 2487 TEUs).
- All time record monthly container throughput of 56,848 TEUs was achieved by KoPT in May'16.
- Record handling of 5,72,757 mt by rail at KDS was achieved in May'16 (by 286 trains in and out).
- KoPT adjudged Major Port of the year in Gateway Award 2016 on 12.8.16 for impressive growth & performance. On 12.5.2016, Kolkata Port was awarded the 3rd position in terms of highest growth rate in traffic in 2015-16 at the review meeting presided by Secretary (Shipping). KoPT adjudged Container Port of the year for 2015-16 by EXIM Group in Kolkata on 6.5.16 and awarded Trophy & Certificate.
- As part of 'Ease of Doing Business', at KDS, the procedure of obtaining 'no objection' of Vessel Operators on Delivery Orders for containers has been discontinued w.e.f 15.11.16.
- KDS is giving concession in wharfage for domestic cars coming by Ro-Ro vessels w.e.f. 7.6.16 to promote Coastal Shipping.
- Online Monitoring has been launched for Port User's Grievance regarding operational issues vide KoPT website (Homepage-Concerns & Care-Grievance).
- Eden channel has become fully operational from 29.02.16 for movement of all ships to/from Haldia: 2724 vessels (1338 inward ; 1336 outward) have passed through the channel during Apr-Dec'16.
- Historic maiden movement of goods to N-E states using India-Bangladesh river protocol route took place in June 2016. A cargo vessel from Kolkata, with consignment for Tripura, reached Ashuganj Port on Meghna river in Comilla district of Bangladesh. Goods thereafter are to be transported by road (32 kms) to Agartala. Agreements with Bangladesh for use of Inland Waterway, Coastal shipping and Bangladesh Ports for short cut transit to North East states.
