Perused the application of KoPT dated 02.02.2012 bearing no. Lnd. 4450/III/12/403 with the prayer to ake necessary action for recovery of dues/ charges with accrued interest for delayed payment against M/s Hind Galvanizing & Engineering Co. Ltd., the O.P. herein. It appears that possession of the public premises in question was taken over on 20.02.2006 and KoPT's claim on account of rental dues for Rs. 4,29,747.32/- for the period upto November, 1999 was duly adjudicated by this Forum of Law vide order no. 8 dated 19.04.2004 under proceedings no. 570/R of 2004. It reveals from ecord that necessary certificate under Sec. 14 of the Act was issued to the Collector, South 24 Parganas on 29.06.2004 under due acknowledgement of the Office of the Collector on 01.07.2004 and KoPT by its statement of accounts claimed rental dues for Rs. 4,29,739/-, excluding interest. Such being the case, I do not find anything to be considered further by this Forum of Law. The Land Manager, KoPT is hereby advised to pursue the matter with the Collector, South 24 Parganas for realisation of arrear rental dues in terms of the certificate issued u/s 14 of the Act in accordance with Law.

FINAL ORDER

The matter is taken up to-day for final disposal. Factual aspect involved into this matter is so simple that I do not consider it necessary to extend it by elaborate discussion. It is the case of Kolkata Port Trust that the O.P. is continuing in occupation of the public premises without any to payment of rental dues to the Kolkata Port Trust in gross violation of the condition of tenancy as granted to them under lease. It is also the case of Kodkata Port Trust (KoPT) that there is no authority on the part of O.P. to occupy the Port property after service of ejectment notice dated 23.9.1999 to O.P. from KoPT's end. Rental dues as claimed by KoPT against O.P. is Rs.4,29,747.32 in respect of the period 1.9.1992 to 30.11.1999. Show Cause Notice U/S.4 and U/S.7 of the Act were issued to O.P. on 27.1.2004 upon formation of my opinion to proceed against the O.P. for eviction and recovery of tental dues under the Act on the basis of the materials brought before me. Sufficient chances were given to O.P. to file thereare their reply to the said Show cause Notices in order to contradict the grounds for eviction as mentioned in the Show Cause Notice Williams U/S.4 and the claim of rental dues as mentioned U/S.7. The O.P. was given liberty to produce document and laid evidence and to file written objection from time to time but no action has been taken on behalf of O.P. to reply against the Show Cause Notice U/S.4 & 7 of the Act inspite of repeated chances. The only statement made on behalf of O.P. is merely and allegation against

against the Kolkata Port Trust regarding payment of Rs.9,57,000/- in excess and abnormaly high rate of charges. As there is no reply to the Show Cause Notice and no papers/documents in favour of O.P's contentions, it is very difficult, I should rather say impossible to accept the contention of O.P. regarding excess payment As a matter of fact the O.P. has failed to make any case regarding his its occupation into the public premix premises. It is my strong and considered view that no one should be allowed to enjoy the public premises without making payment for such enjoyment. In course of hearing I specifically m asked the O.P. regarding their view for making payment to Kolkata Port Trust atleast on ad-hoc basis pending final decision on merit. But the O.P. expressed their inability to pay up the dues/charges to Kolkata Port Trust. However, as there is no reply to the Show Cause Notice/s inspite of repeated chances, I do not find any scope but to allow the prayer of Kolkata Port Trust regarding order of eviction and payment of rental dues against O.P. on the following reasons :

- That the O.P. has failed and neglected to pay the rental dues to the Kolkata Port Trust in gross violation to the fundamential condition for grant of tenancy under lease.
- That the ejectment notice dated 23.9.1999 as served upon the O.P. by the Kolkata

Kolkata Port Trust Authority is valid, lawful and binding upon the parties.

- That the O.P. has failed to file Show Cause and failed to produce any paper/document and also failed to te laid any evidence in support of their occupation into the public premises inspite of repeated chances.
- That the O.P. has lost its authority to occupy the public premises after expiry of the period as mentioned in the Notice of ejectment dated 239x 23.9.1999 that is to say on and from 1.12.1999 and the O.P. is liable to pay damages for such unauthorised use and occupation of the public premises up to the date of recovery/handing over of clear vacant and peaceful possession by/to Kolkata Port Trust.


