I. NOTABLE ACHIEVEMENTS / DEVELOPMENTS

Organizing PPP Maritime Conclave 2022

- SMPA in association with FICCI organized a twoday (August 17 & 18, 2022) PPP Conclave on multi-modal transport to explore avenues in the shipping services by introducing the PPP model.
- At SMPA, there are three PPP projects with an investment of around ₹750 cr. for which LoI has already been awarded and SMPA is expected to attract around ₹2500 cr. investment over the next 3-4 years under the PPP mode.
- The landlord model is the model for the future where the ports will be more of a regulator and the services will be provided by the private sector under PPP mode. Multi-modal connectivity is aimed at developing infrastructure to reduce logistic costs and boost the economy
- LOA issued on 17.8.2022 to M/s Hooghly Oil & Gas Terminal for setting up of Liquid Cargo handling Jetty alongwith associated facilities at Shalukkhali, Haldia Dock-II.



Signing of MoU between SMPA & CSL and handing over profit sharing cheque to SMPA by CSL

- On 01.08.2022, SMPA & Cochin Shipyard Limited signed an MoU for cooperation on Sustainable Green Technology Solutions at CSL Kochi.
- CSL handed over a "profit sharing" cheque of ₹ 3.78 Cr. for the FY 2021-22 to Shri Vinit Kumar, Chairman, SMPA, as a part of their joint operations at the CKSRU in Kolkata.

- ➢ On 16.08.2022, Shri Sarbananda Sonowal. Hon'ble Minister of MoPSW inaugurated the new state-of-the-art Hooghly Cochin Shipyard Ltd in Kolkata in presence of Shri Shantanu Thakur, Minister of State, MoPSW.
- ▷ A new horizon emerged in the Inland Waterway Vessel Construction with commencement of ₹173.52 cr. project by Hooghly Cochin Shipyard Ltd., a fully owned subsidiary of Cochin Shipyard Ltd which will act as the lead shipyard utilizing the immense potentiality of NW 1 and NW 2.

Arrival of Cape Vessel MV MINERAL YANGFAN

MV MINERAL YANGFAN, a Cape Vessel with LOA 299.92m and Beam 50m, a/c SAIL has reported with the highest parcel load of 69,275 MT of Coking Coal for lighterage with Floating Cranes at Sagar Anchorage on 31.08.2022. Earlier, such distinction was achieved by MV CAPE SWAN, another cape vessel, which arrived with 66,774 MT of Coking Coal at HDC on 09.08.2022.

Trial movement of Containers through Barge from KDS to North East India via Bangladesh

Trial movement of 2 Containers and some Break Bulk Cargo moved by Barge MV Rishad Rayhan from Khidderpore Dock to two different locations in the North East India viz Silchar (Assam) and Nongpoh (Meghalaya) via Mongla, Bangladesh, took place taking advantage of the Agreement of Usage of Chittagong & Mongla Ports.

II <u>CARGO THROUGHPUT</u>:

- SMPA, Kolkata handled 25.269 million tonnes (mt) of cargo during April 2022-August 2022, vis-àvis 23.097 mt during Apr'21-Aug'21, registering an increase of 9.40%.
- HDC handled 18.818 mt of cargo during Apr'22-Aug'22 vis-à-vis 17.160 mt during Apr'21-Aug'21 (an increase of 9.66%). KDS handled 6.451 mt of cargo in Apr'22-Aug'22vis-à-vis 5.937 mt during Apr'21-Aug'21 (growth of 8.66%).
- HDC registered growth in respect of POL (Crude), LPG, Manganese Ore, Other Ore, Lime Stone, Coking Coal, Other Coal, Petroleum Coke, Fly Ash etc. while KDS had growth in respect of Vegetable Oil, Other Liquids, Finished Fertiliser, Iron & Steel, Pulse, Coking Coal, Other Coal, Lime Stone, Container (TEUs) etc. during Apr-22 to Aug-22 vis-à-vis corresponding period of last year.

- HDC of SMPA recorded the highest handling of Coking Coal to the tune of 13,20,546 tonnes in August 2022 surpassing the previous highest of 10,25,637 tonnes of Coking Coal in June 2022.

- SAIL has handled the highest volume of Dry Bulk vessels at HDC, SMPA. A record quantum of 10,62,054 tonnes of Dry Bulk cargo in 33 vessels have been handled by SAIL at HDC in August 2022 surpassing the previous highest of 8,54,675 tonnes Dry Bulk in 27 Vessels during July 2022.

- HDC of SMPA achieved the highest ever handling of cargo at Berth No. 14 in a single day when MV CORATO has unloaded 30,398 MT of Coking Coal on 17.08.2022, Previously, such distinction was achieved by MV NS NINGBO, wherein a quantity of 29,287 MT of Iron Ore Fines was loaded in a single day on 16.07.2020.

> III <u>CONTAINER TRAFFIC</u>:

SMP, Kolkata handled 2,91,239 TEUs (KDS:2,43,586 & HDC: 47,653) during Apr'22-Aug'22 visà-vis 3,19,688 TEUs (KDS:2,41,941 & HDC: 77,747) during Apri1'21-Aug'21.

IV <u>SHIP TRAFFIC</u>:

During Apr'22-Aug'22, 1223 ships (KDS: 441, HDC: 782) called at SMP, Kolkata vis-a-vis 1216 ships (KDS: 401, HDC: 815) in Apr'21-Aug'21. 1572 vessels (782 inward; 790 outward) passed through Eden Channel during Apr'22-Aug'22 to / from Haldia.

V <u>COMPARATIVE PERFORMANCE</u> :

SMP, Kolkata ranked 1st in handling of Coking/Other Coal and 2nd in handling of both Other Liquids & Other Miscellaneous Cargo amongst the Indian Major Ports during April-August 2022. SMPA got elevated from 6th to 5th position in cargo handling amongst the Major Ports during the period under review vis-a-vis April-August 2021.

VI <u>RAILWAY TRAFFIC</u> :

- During Apr'22-Aug'22, SMPA, Kolkata handled rail-borne traffic of 14.53 mt (KDS-2.67 mt & HDC-11.86 mt) against 12.23 mt (KDS-2.21 mt & HDC-10.02 mt) in Apr'21-Aug'21, registering a growth of 17.68%. During Apr'22-Aug'22, 671 rakes were received and 691 dispatched at KDS; at HDC, 2659 rakes were received and 2654 were dispatched during the same period.
- HDC of SMPA, Kolkata handled highest ever monthly rail-borne traffic of 2.65 million tonnes in August 2022 surpassing the previous highest record of 2.55 million tonnes handled during July 2022.
- ➢ HDC further recorded highest ever daily interchange of 49 trains on 05.08.2022 surpassing the previous highest record of 45 trains achieved on 22.07.2022.
- HDC recorded highest ever monthly Interchange of 1219 trains (Inward 605 & Outward 614) in August 2022 surpassing the previous highest of 1195 trains (Inward 606 & Outward 589) achieved during July 2022.
- HDC also recorded highest loading of 602 rakes (2.22 million tonnes) in August 2022 surpassing the previous highest record of 588 rakes (2.17 million tonnes) achieved in July 2022.
