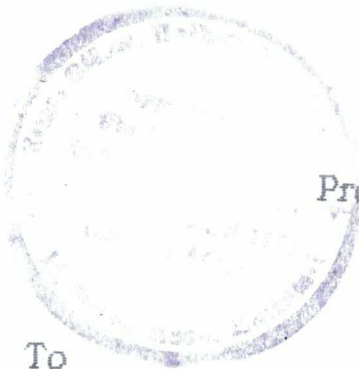

WHEREAS, Proceedings against Smt. Panchi Debi & Smt. AND WHEREAS, the report of the Process Server dated 18.9.2015 and 14.10.2015 also reveals that "O.P. was not found at the above address".

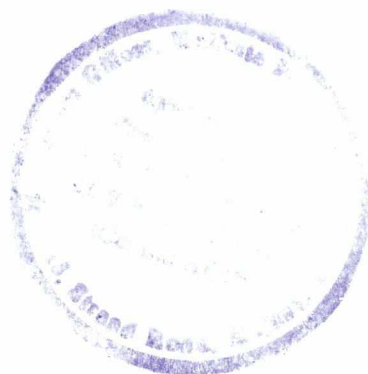
AND WHEREAS, no reply to the show cause notice/s has been filed as yet.

NOW THEREFORE, in exercise of the power conferred upon me, I hereby give you notice to file reply to the Show Cause Notice/s on or before 21.1.2016 and to appear before me on 25.02.2016 at 3.00 P.M. either in person or through authorised representative(along with a letter of authority) capable of answering all material questions in respect of the property described under the Schedule below, failing which the matter will be decided exparte without any further reference.
