Candidate must have obtained Marine Engineer Officer Class III (NCV -2^{nd} Engineer) License from Director General of Shipping, Ministry of Shipping, and Govt. of India.

Experience:

<u>Terms and conditions for engagement of Marine Engineer Officer Class III (NCV – 2nd Engineer) under M.O. Division on contractual basis</u>

- The engagement will be for a period of 2 months and on expiry of the said period, the contractual engagement will be automatically terminated. However, on expiry of the contract, HDC, KoPT reserves the right to enter in to a fresh contract for such period and on such terms as may be mutually agreed upon by the parties.
- 2) The selected candidate will be engaged as Marine Engineer Officer on round the clock duty for a period of 2 months at a stretch.

- 9) On official tour outside headquarters of Haldia Dock Complex, you will be entitled to TA / DA, as applicable to regular incumbents in the post of Engineer-In-Charge, under MO Division, HDC.
