Generalterms&conditionsforPort DivingOfficer(oncontract):

- i) The engagement will be for a period of 03 (three) years and on expiry of the said period, the contractual engagement will be automatically terminated. However, on expiry of the contract, HDC, SMP-K reserves the right to enter into a fresh contract for such period and such terms as a smaybemutually agreed upon by the parties.
- ii) Theselected candidate will be responsible for all Diving Works, Diving operations and all administrative jobs pertaining to Port Diving Unit. The selected candidate shall assist Deputy Manager (M.O.) in maintenance, procurement and A.M.C. of all Diving equipment. The selected candidate has to act as in-charge of the establishment depending upon seniority.
- iii) Thecandidatewillbepaidaconsolidatedremuneration of ₹46,500/-(RupeesForty-sixthousand five hundred only) per month. The rate of Annual Increment would be decided by the Competent Authority, subject to Annual Performance Review after completion of each year of service, during the tenure of contract.
- iv) The selected candidate will have to work for 6 days in a week and will be entitled to a weekly-off day. If situation sowarrants, the weekly day of rest may be changedwith prior intimation. Hewill be required towork normally in general shift but may have towork in shift son rotation, i.e. morning, afternoon, night as per requirement. In exigency of work, he may also be booked on weekly off days / Holidays, for which appropriate relief may be considered, as per the discretion of the Competent Authority. He will also have to attend emergency calls, as per requirement, beyond his normal duty hours, without any extra remuneration for the same.



- vii) The selected candidatewould be entitled to indoor & outdoor medical facilities as are availablein the Port Hospital at Haldia for self, spouse and a maximum of two 'dependent' children uptothe age of 21 years. In case of having twins or more during the second child birth, all the childrenborn together inclusive of 1st and 2nd child birth would be considered for the above medicalfacilities.Besidesthefollowingmedical facilities would alsobeavailable:
 - a) <u>PurchaseofMedicines</u>:-PurchaseofmedicinesfromdesignatedmedicalstoreatHaldia,as would be prescribed by the Port Hospital on cashless basis, may be allowed. Payment ofthe samewould be made byHDC.
 - b) <u>Pathological tests:</u>All pathological diagnostic tests, as would be prescribed by the PortHospital,may beallowedtobedoneat the Port Hospital as well as at designatedlaboratoriesatHaldiaandtheexpenditureof the same would be reimbursed / paid directlybythe Port.
