

Excerpts of the pre bid meeting held in the room of Superintendent, New constructions at 1500 hrs on 14.06.2018 for Hiring of a Motor Boat at Berthing/Mooring of vessels and cleaning of Dock Water at KPD/NSD

Pre Bid meeting was held in Superintendent, New Construction's room for the tender of Hiring of a Motor Boat at Berthing/Mooring of vessels and cleaning of Dock Water at KPD/NSD in the presence of representative of firm i) M/s. Milan Marine Service. Ltd.

The estimated cost of the subject tender is Rs. 29.79 lakh in two cover bids and now it has been decided that the tender will be invited in one cover bid.(No.Admn/6460/3/Systems Improvement, dt: 08.02.2018 )

Therefore, it is necessary to issue addendum for opening of both the parts (Part-I i.e. Techno-Commercial bid & Part- II i.e. Price bid) simultaneously on the scheduled date of opening of Techno-Commercial Bid which is fixed on 28.06.2018.
