#### TERMS AND CONDITIONS FOR TENDER No.: HDC/MM/DRESSING/LT-18/34/28

#### 01. **SCOPE OF WORK**:-

The work comprises supply and delivery of Dressing Items mentioned in the Bill of Quantities of HDC's Port Hospital at Haldia, as per part orders issued from time to time during the period of the contract.

#### 02. **PERIOD OF CONTRACT**:-

The Rate Contract would normally be for a period of **two years** and shall be valid for all part orders to be placed by HDC within this period. The contract period may be extended for 3 months, if considered necessary by Manager (M.M).

#### 03. **QUANTITY: -**

The quantities of the item(s) as mentioned in the Bill of Quantities are only indicative. Procurement will be made as per our time-to-time actual requirement by placing part orders as per Terms and Conditions of Biennial Contract. The Trustees' reserves the right to place no order in case of no requirement during the period of contract including extended period, if any.

#### 04. **PRICE:-**

Tenderer should quote **HOSPITAL PRICE** on F.O.R. Port Hospital (Haldia Dock Complex), Haldia Township, Haldia basis i.e. free delivery up to HDC's Port Hospital. The Price shall remain firm and fixed during the period of the contract including extended period, if any.

- 05. **PRICE FALL CLAUSE**:-In case of downwards revision of price, the Manufacturer/Principal shall forthwith send intimation to the Manager (MM) / M.S. Port Hospital, HDC mentioning the revised price, Date of revision and the Batch Number and lower price will be applicable. No upward price revision is applicable.
- 06. **PRICE EVALUATION:-**Evaluation will be made on the **lowest rate (L1) basis**, quoted against individual items among the techno-commercially qualified bids and accepted samples. In case bidders quote the same rate originally, the work will be split equally.

#### 07. **TAXES**: -

VAT will be paid extra as applicable on quoted rate and prevailing rate in % to be mentioned. Please note that we do not issue any Declaration Form for concessional Sales Tax/VAT i.e. **full Sales Tax/VAT** will be applicable.

- 08. i. Micro & Small Enterprises (MSEs) registered with NSIC (under single point registration scheme) are exempted from depositing cost of Tender Document and Earnest Money having valid NSIC Certificate for MSEs along with DIC's (DISTRICT INDUSTRIES CENTRE) Certificate.
  - ii Micro & Small Enterprises (MSEs) registered with NSIC under Single Point Registration Scheme (SPRS) are eligible to get the benefits under new Public Procurement Policies for MSEs as notified by Govt. of India, Ministry of Micro, Small & Medium Enterprises (MSME) vide Gazette Notification, dated 26.03.2012.
    - When splitting of tender quantity is not possible purely on technical ground, trustees reserve the right not to negotiate price with MSE if their price is within the band of L1 +15% in comparison with L1 price on non-MSE for consideration of award of order for 20% of tender quantity against any item as per new public procurement policy.
  - iii. If Micro & Small Enterprises (MSEs) registered with NSIC intends to participate in the tender, for the items they are not registered with NSIC, then they will have to deposit cost of Tender Document, full amount of Earnest Money as per NIT. Otherwise their offer for those items will not be considered.
  - v. Copy of valid NSIC Certificate for MSEs along with DIC's (DISTRICT INDUSTRIES CENTRE) Certificate has to be submitted along with the bid.

#### 09. **DELIVERY: -**

- a) Dressing Items will have to be supplied immediately on the placement of part order and not later than **30 days** from the issue of respective part order.
- b) Delivery to be made at the General Stores, Port Hospital, Haldia Township, Haldia on working days i.e. other than Port Holidays & Sundays between 10.00 A.M. to 12.00 Noon and 2.00 P.M. to 4.00 P.M.
- c) Supply from fresh batch with long expiry date will be accepted and those having short expiry date may be rejected at the discretion of Medical Superintendent, Port Hospital, Haldia Dock Complex. In any case, Dressing Items having less than 3/4<sup>th</sup> of the shelf-life will not be accepted unless permitted by the M.S. Port Hospital.
- d) If Dressing Items are found substandard/ defective/ damage they are to be replaced free of cost by supplier or else cost of the items will be deducted from bill on pro-rata basis.
- e) The Dressing Items may be supplied directly by the Company/Manufacturer or their authorized distributor / dealer for which letter of authorization will have to be sent indicating the name and address of the authorized distributor/dealer. The Company as well as the principal shall, however, remain responsible for all the terms and conditions of the tender and the materials supplied by them / or their authorized distributor/dealer.

#### 10. ORDER CANCELLATION: -

If the supplier fails to deliver materials within the stipulated time, HDC,KoPT reserves the right to cancel the order.

#### 11. **PAYMENT:** -

Within 30 (thirty) days from the date of submission of the clear bill accompanied by receipted challan and other documents required for processing the bill (in four sets). Payment will be made through Bank NEFT/ RTGS System for which supplier should furnish their banker's name, address and account number, IFS Code etc.

#### 12. VALIDITY OF OFFER: -

Period of validity of offer shall be **120 days** from the date of opening of Tender.

#### 13. **ACCEPTANCE OF TENDER:** -

The Trustees are not bound to accept lowest or any tender and reserves the right to accept a tender is full or in part and / or reject any tender in full or in part without assigning any reason thereof.

#### 14. **SAMPLE** :-

- 14.2 Sample selection will be carried out by the committee of Doctors of Port Hospital of HDC in presence of all participating bidders considering quality and suitability of items for treatment purpose. Decision of sample selection committee for selection of sample would be final and binding upon bidders. Price would be considered for selected sample only subject to fulfillment of terms and conditions of tender.
