**PROCEDURE OF PAYMENT OF EARNEST MONEY AND BID DOCUMENT FEE  
THROUGH AXIS BANK GATEWAY**

1. The Bidders would be able to access the payment gateway from the Vendor log in page of the MSTC ecommerce site ([www.mstcecommerce.com](http://www.mstcecommerce.com) → e-Procurement → Psu / Govt depts. → Kolkata Port Trust) under the icon: "**HDC EMD/Tender Fee Payment**". Clicking this icon will take the Bidders to the Axis bank gateway.

Alternatively, the Bidders can also access the gateway by from Axis bank easypay website site (<https://easypay.axisbank.co.in> → others → Haldia Dock Complex)

2. The Bidder will be required to mention the **Bidder's ID** (The ID used by the Bidder for logging in the MSTC Website) and **Bid Id** (E-tender Number of the Tender against which the Bidders intend to submit Bid) and then Click '**VALIDATE**'.
3. A webpage will populate where the Bidder will be required to select: **Earnest Money** Or **Bid Document Fee**, then indicate his Mobile Number and the CAPTHA displayed in the webpage.
4. Depending on the selection, another webpage will come up.
5. In case of selection of Earnest Money, The bidder will be required to select the option of With or Without Bank Guarantee. In case of Bids, where there is no option to pay through BG, the Bidders should select the option 'Without'.

In case of any tender, where there is an option to pay a part of EM through Bank Guarantee and the Bidders wants to avail that option, the bidder should select 'With'.

6. The Bidder will be required to mention their Bank Account Number, IFSC Code of his Bank, and the Name of the Account, insert the Captha mentioned in the web page and then '**SUBMIT**'. In case of Bid Document Fee payment, Bank Account Number would not be required.

An URN Number will be generated. Bidders may keep note of this URN Number for all future reference.

7. Another webpage will come up and the Bidder will have the option to select payment methods from –

8. In case of selection of Internet Banking, the bidder will be required to select any Bank of their choice and depending on the selection the bidder will then be guided to the webpage of the respective Bank. After validating the payment in the respective bank, the system will return to the Axis Bank Payment gateway.

9. In case of selection of RTGS/NEFT, the webpage will generate a payment advice.

### **9.0 TECHNICAL SPECIFICATION OF LIFE LUBRICATED IDLERS**

9.1 **GENERAL:** - The life lubricated conveyor Idlers specified hereunder shall generally conform to the overall limiting dimensions as per the relevant drawing enclosed.

#### **9.2 GENERAL SPECIFICATION:**

**Specification:** - Idlers should conform to this specification and wherever not specified, latest publication of IS-8598, 1977 with its latest amendments, shall be applicable.

**Protected Bearing Housing:** - The Idlers shall have pressed Steel Bearing Housing with suitable sealing arrangement for protection against ingress of dust and moisture.

**Lubrication:** - Idlers should be grease packed for life, grease to be of good quality, water repellent and with high flash point.

**Precaution During Assembly:** All care shall be taken to avoid damage to bearing seals in the housing and spindle.

#### **9.3 MATERIAL SPECIFICATION:**

9.3.1 **PIPES:** - The Idlers should be made using ERW Pipes conforming to Grade 210 of IS-9295 of 1979 with its latest amendment.

Wall thickness of all idlers- 5.4 mm. Nominal with permissible tolerance as per IS-9295.

**Co-Axiality:** The pipes used for manufacturing Idlers shall be machined at both ends in one setting to maintain co-axiality.

9.3.2 **BEARING HOUSING:** The Bearing Housing shall be simultaneously welded to the pipe at both the ends to eliminate distortion. The welding equipment used shall give smooth continuous and strong welding so that both Housing and Barrel are fused together with required strength. The welding shall be free of blowholes, cracks, splattering etc. and shall be continuous without excessive convexity.

9.3.3 **BEARING:** SKF Make BBIB 420206 ANTI SEIZE Ball Bearings or equivalent FAG Make.

The Spindle shall be ground at the Bearing Sealing Area with required tolerance.

#### **9.4 CRITICAL DIMENSIONS TO BE MAINTAINED:** -

**N.B.** Idlers will be selected at random and the manufacturer shall carry out the tests, including Destructive Tests, at their works in presence of HDC's representative. Inspection will be carried out at Manufacturer's premises, prior to dispatch, for each batch offered. Cost incurred (if any) for the tests, including Destructive Tests, is to be borne by the Manufacturer.

Destructive Test(s) will be carried out as per the following:

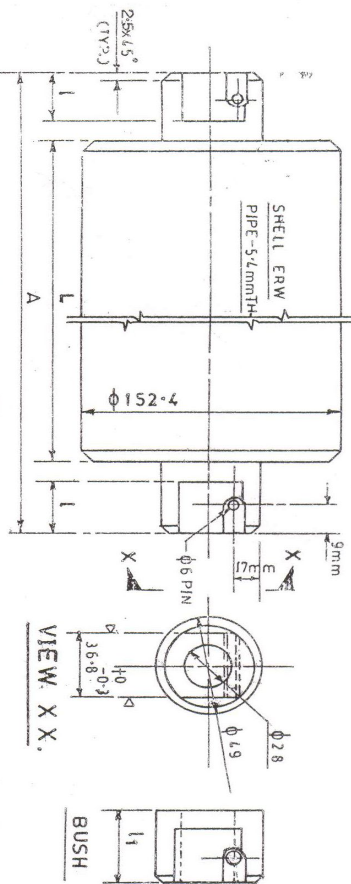

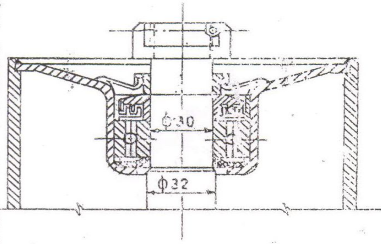
