1	Mere participation in e-tender will not mean that a particular bidder will be automatically considered qualified and their bids will be entertained. Such qualification will be reviewed at the time of evaluation of bids also.
2	Price Bids (Part-II) of only those eligible bidders whose Part-I Bids are complete and in order shall be opened on time and date to be intimated later separately.
3	The Terms and Conditions of E-Tender shall be read in conjunction with the General Conditions of Contract (available in KoPT website → Rules & Regulations → Non-service Regulations), Bill of Quantities and other documents forming part of this Contract wherever the Contract so requires.
4	The several documents forming the Contract shall be taken, as mutually explanatory to one another and in case of any discrepancies, the Bill of Quantities shall prevail over the Specifications and the Terms and Conditions over the General Conditions of Contract of KoPT. Annexure –C

NOTICE INVITING TENDER

SCOPE OF WORK:

The 'Works Contract' shall comprise of the following works at HSFO (Berhampore) :

1. Operator will be required to ply the boat as and when necessary as per instruction of officer in charge. The motorised country boat should be large flat type with adequate cover for the protection from Sun and rain. It should be large enough to accommodate 4 persons for night halt. The boat should be fitted with motor of adequate power to facilitate easy maneuvering during storm. The boat must be provided with an operator.
2. Three (3) Labourers to be provided should be acquainted with the hydrographic survey of the river and preferably have knowledge of the River Bhagirathi for assisting the survey works in the Bhagirathi/ Hugli river system.
3. The motorised country boat with Operator and Labourers as mentioned in the item above may be hired as and when required. The number of Labours will be hired as per actual requirement during the works.
4. All requirements for the smooth running of the motorised country boat should be borne by the supplier (i.e. Operator, repairs, maintenance of the boat etc).
5. Cost of fuel will be paid @ 2.2 Litres per hour run for the motor - driven country boat and will be based on the actual run of the engine. Considering the price of Diesel as Rs. 60.97 per Litre (as on 22.11.2017), the cost of fuel (including Mobil) will be paid @ Rs. 134.112 per hourly run of the boat. The log book has to be maintained for actual run of the boat and it has to be kept under the custody of the station in charge.
6. The running rate for the motorised boat as mentioned above will be increased / reduced proportionately compared to the price level of diesel prevailing on 22.11.2017, in case diesel price is revised by the Govt. of India.
7. The motorised country boat with Operator and Survey Labourers will be required to work in the Bhagirathi- Hugli River system and elsewhere where Port Authority directs in the interest of Trustees work.

8. The Labourers and the Operator will be required to assist in the hydrographic survey of the river Bhagirathi – Hugli by carrying materials and equipments from place to place, for accommodation if required should be provided by the contractor.
9. The contractor has to supply one motorized country boat with Operator and 3 nos. Labourers on receiving requisition from Senior Scientific Officer, HSFO Berhampore or his authorized representative within three days from the date of receipt of the letter. Such requisition will cover a maximum of 400 days in the contractual period of two years i.e maximum 200 days per year.
10. If the motorised boat with Operator and Labourers are found unsuitable/unwilling for the work, the contractor would be required to replace the same within two days as per direction of the site-in-charge.
11. If the contractor fails to provide the boat and personnel as directed by the Senior Scientific Officer, H.S.F.O, a penalty will be made for each of the items of supply at double rate arrived from the tendered rate on pro-rata basis.
12. If the boat is found not functioning satisfactorily, the supplier must repair / replace the boat within 48 (forty eight) hours, else the contract may be terminated all together with a notice of 72 (seventy two) hours. The safety of the boat in plying condition , license/plying certificate if any, is to be guaranteed by the contractor and it will be under the risk and responsibility of the contractor in totality throughout the contract period.
13. Non-compliance or failing to execute the work within the stipulated time is liable for penal action. Any delay in supply the motorised country boat with one Operator, and three Labourers beyond the stipulated time will attract imposition of liquidated damage on the bidder @ 0.5% of the monthly hiring charges per week from the next day onwards after the expiry of last date of completing the same subject to a maximum of 10% of the accepted contract value for the job. Kolkata Port Trust will recover the amount of liquidated damage imposed on the successful bidder from their submitted bill or otherwise as the case may be.
14. The boat with motor and other survey instrument should be under custody & security to be deployed by the contractor. The Trustee will not be responsible in any case whatsoever for any theft or damage of the boat and motor etc. during the period of contract.
15. Minimum wages are to be payable to the Operator and Labourers as fixed by the Central Government during the period of contract. The responsibility of making payment is totally the responsibility of the contractor. Escalation on this account is admissible subsequently later on. The contractor should ensure compliance of prevailing Minimum Wages Act and any other Act that may be applicable and will also absolve Ko.P.T from any dispute as a

result of non-compliance of any of the relevant Acts that are / will be in force. The operator and labourers must be enlisted for PF and ESI and deposit the same respective accounts of individuals. The contractor should handed over the respective A/C no. to his employee.

16. Payments shall be arranged on the basis of monthly bills to be submitted in quadruplicate duly certified by the station in charge along with duly certified logbook, by the supplier after due scrutiny as per Trustees' normal procedure of payment through ECS. The relevant particulars in this regard are to be furnished.

Pre-qualification Criteria

The prequalification criteria will be as follows and the bidder is required to upload the scanned copy of the following documents as part of its Techno-commercial bid:

- I. Self certified true copy of documents as proof that bidder has its own Registered office in West Bengal
- II. Self Certified true copies of PAN, latest Income Tax return, Goods and Service Tax (GST) registration certificate issued by competent authority.
- III. Self Certified true copy of ESI registration certificate issued by competent authority
- IV. Self Certified true copy of EPF registration certificate issued by competent authority.
- V. The Earnest Money of the successful bidder will be converted to part of Security Deposit(SD) and the remaining security deposit will be recovered from the contractor's each and every on Account Bill [including the final bill, if necessary] at the percentage of each such bills as set forth in Clause.3.4,3.5 & 3.6 of the General Conditions of Contract(GCC). Refund and forfeiture of SD shall be guided by Clause 3.5(i) & (ii) of the GCC. The Earnest Money Deposit of the unsuccessful bidders will be returned without interest, after issuance of Work Order to the successful bidder. Details of remittance should be entered by the participating bidder in the space provided in the e-tender

Cost of Tender Document

Before submitting the bids, bidder has to submit Banker's Cheque or Pay Order or Demand Draft amounting to. Rs. 1,000/- (One thousand) only [Non - refundable], in favour of “Kolkata Port Trust”, drawn on a Nationalized Bank of India and payable at Kolkata, towards the cost of Tender document. The same should be submitted along-with EMD physically at Hydraulic Study Department in a closed cover, with a forwarding letter addressed to Chief Hydraulic Engineer, as per the Schedule of Tender. Non-compliance of this stipulation shall render the tender offer informal and it will be rejected. Details of remittance should be entered by the participating bidder in the space provided in the e-tender

Mode of submission of Bids

All bidders must submit their offers through e-tendering in accordance with the terms and conditions set out in the bid documents and no deviation will be accepted. Techno-commercial Bid i.e. Part-I shall also contain the following documents which are to be uploaded, apart from the

documents mentioned under Pre-qualification Criteria. The bidder will have to produce the original documents or any additional documents, if asked for, to satisfy the Authorities.

- a) That the Bidding Firm has not been debarred / de-listed by any Govt. / Quasi Govt. / Public Sector undertaking in India.
- b) The proprietor / partner(s) / authorized signatory of the bidding firm (in the case of proprietorship firm / partnership firm / limited company , as the case may be) is / are not associated with any other firm bidding for the same work.

Price Bid i.e. Part-II, as per BOQ and Form A to be uploaded (scanned copy duly filled up & signed by the bidder).

Validity of offers

The e-tender shall remain valid for a period of **4 (four) months** from the date of opening the same. If before expiry of this validity period, the Bidder amends his quoted rates or tender, making them unacceptable to the Trustees and / or withdraws his e-tender, the Earnest Money deposited shall be liable to forfeiture at the option of the Trustees/ Sanctioning Authority / Engineer.

Time of Completion of the Work

The time of completion for the work shall be two years from the date of acceptance of the Work Order **OR** expiry of respective maximum number of operations (days) (i.e 500 days), whichever achieved earlier.

Price Quote by the Bidder

The bidder has to quote the hiring charge per day of the motorised country boat. For engagement of survey labourers and operator, the bidder has to quote the percentage only over minimum wages. This percentage includes his / her own margin of profit and all statutory obligations like hike in Minimum Wages, EPF, ESI, Bonus (if applicable, payable as per Payment of Bonus [Amendment] Act, 2015) for the contractual period and any other expenses / tools, for engaging such operators. KoPT would pay to the contractor, the fixed percentage of profit (during the tenure of the contract) quoted by the contractor, calculated on variable Minimum Wages only, as stated above along with the boat hiring charge.

GST would be considered extra as per the extant rate. Any modification (GST) in taxes or duties, during the tenure of the contract, by the GoI, shall be applicable. The detailed tax break-up considered in the quoted price should also be submitted by the bidders. Any offer without detailed tax break-up, will not be accepted. Any recovery due on account of subsequent modification in taxes & duties shall be assessed by KoPT, without any reference to the contractor and shall be made by KoPT from the amount payable under the contract

If the present rate of Minimum Wages is Rs. 100/- (say) per day & if the contractor's quoted profit percentage is 15%, (say) then KoPT would pay presently Rs. $100 \times 1.15 = \text{Rs. } 115/-$ per day multiplied by the total man days.

Likely, if the rate of minimum wages changes to Rs. 120/-(say), KoPT would pay Rs. $120 \times 1.15 = \text{Rs. } 138$ per day multiplied by the total man days in future. GST will be paid extra as per existing rate.

Evaluation of the Tender

Bids will be evaluated on the basis of pre-qualification criteria and subsequently the lowest bidder {i.e. Rs. $(A+B*4* \text{ min. wages}) = \text{Rs.} \dots$ } under BOQ of Price Bid.

During the course of examination of Techno–Commercial bids, the bidders, if asked for, shall produce the original documents or any additional documents, if asked for, to satisfy the Authorities. The price bids of those bidders who meet the qualifying criteria of NIT shall be opened.

During Techno–Commercial Evaluation, i.e. evaluation of tender, an offer shall be considered nonresponsive in case:-

- (i) is not accompanied by requisite earnest money
- (ii) is not accompanied by requisite tender paper cost
- (iii) Validity of the offer is less than tender stipulation
- (iv) It does not meet the Qualification Criteria as stipulated in the NIT
- (v) The bidder submits conditional offer / impose own terms and conditions / does not accept tender conditions completely.
- (vi) Requisite documents as per NIT are not uploaded.

In addition to above, a bidder may be disqualified if –

- a) The bidder provides misleading or false information in the statements and documents submitted
- b) Record of unsatisfactory performance during the last seven years, such as abandoning of work or rescinding of contract for which the reasons are attributable to the non-performance of the contractor or inordinate delays in completion or financial bankruptcy etc. The decision of Kolkata Port Trust in this regard shall be final and binding on the bidder.

Tax Clause

For Tax inclusive contracts

- Prices or fees quoted in the offer by the bidder shall be inclusive of GST and/or other statutory levies, taxes, cess imposed by Competent Authorities unless otherwise provided.

For Tax exclusive contracts

- The prices quoted above shall be exclusive of any statutory levies and/or other charges levied by any Central / State / Local authorities which shall be paid extra at applicable rates at the time of supply of goods / services.

Change in law clause

- Any new statutory levies, taxes, duties, cess etc. imposed by the Central /State/Local authorities by way of fresh notification subsequent to the issue of Work Order/ Purchase Order, but within the stipulated delivery period, shall be paid extra.
- Any additional cost or benefit impacting the contract price resulting from introduction of any new law, towards leviable taxes, including eligible credits, in respect of goods and services to be supplied under the Contract, then the Parties agree to an adjustment to the contract price to reflect the financial impact of such “Change in Law”.

General Terms & Conditions

- Supplier/service provider to confirm that the GST amount charged in invoice is declared in its returns and payment of taxes is also made.
- The Supplier / Service Provider agrees to comply with all applicable GST laws including GST acts, rules, regulations, procedures, circulars & instructions there under applicable in India from time to time and to ensure that such compliance is done within the time prescribed under such laws. Supplier / Service Provider should ensure accurate transaction details, as required by GST laws are timely uploaded in GSTN. In case there is any mismatch between the details so uploaded in GSTN by Supplier / Service Provider and details available with Kolkata Port Trust, then payment to Supplier / Service Provider to the extent of GST relating to the invoice/s under mismatch may be retained from due payments till such time Kolkata Port Trust is not sure that accurate tax amount is finally reflected in the GSTN to KoPT’s Account and is finally available to Kolkata Port Trust in terms of GST Laws and that the credit of GST so taken by Kolkata Port Trust is not required to be reversed at a later date along with applicable interest.
- Kolkata Port Trust has the right to recover monetary loss including interest and penalty suffered by it due to any non-compliance of tax laws by the supplier / service provider. Any loss of input tax credit to Kolkata Port Trust for the fault of supplier shall be recovered by Kolkata Port Trust by way of adjustment in the consideration payable
- Supplementary invoices/ Debit Note / Credit Note for price revisions to enable Kolkata Port Trust to claim tax benefit on the same shall be issued by you for as particular year before September of the succeeding Financial Year

- The purchase order / work order shall be void, if at any point of time you are found to be a black listed dealer as per GSTN rating system and further no payment shall be entertained

Settlement of Disputes

If a dispute of any kind whatsoever arises between the Employer and the Contractor in connection with or arising out of the contract or the execution of the works, the same shall be dealt as per relevant provisions of the General Conditions of Contract

Mode of Billing and Payment

Payments shall be arranged on the basis of monthly bills to be submitted in quadruplicate duly certified by the station in charge along with duly certified logbook, by the supplier after due scrutiny as per Trustees' normal procedure of payment through ECS.
