## Terms and Conditions of Biennial Contract

## 1. Fees for Valuation

Fees for valuation will be paid in accordance with Wealth Tax Act (Rule – 8C) of Income Tax Department. Discount, if any, on the fees can be offered in the quotation clearly and the discount will remain firm during the currency of contract including extension.

# 2. <u>GST</u>

Tenderer should be registered under GST Act and have GST registration number. Current rate of GST in percentage (%) should be mentioned in the offer.

## 3. <u>Time of Commencement of Work</u>

Authorized representative(s) has to be deputed at HDC's site within seven (7) days from the date of Order Letter to carry out physical inspection and work. The appointed valuer(s) may be required to take dock permit to carry out valuation work inside the dock on paying necessary charges.

## 4. Transport, Food & Lodging

Transportation of two (2) personnel from Kolkata to Haldia and back including local transport at Haldia for visiting sites will be arranged and provided by HDC free of cost. Standard Indian veg / non-veg lunch for two (2) personnel will be provided free of cost by HDC on the day of work at HDC. No lodging & boarding will be provided.

## 5. Submission of Valuation Report

Report with RESERVE SALE PRICE of each and every lot will have to be submitted in a sealed envelop superscribing 'Valuation Report' and HDC's letter reference within ten(10) days from the date of site visit.

## 6. <u>Payment</u>

Payment will be made within three (3) months after submission of Valuation Report with Reserve Sale Price (RSP) against Bill which is to be submitted separately (not in the envelope of RSP). Payment will be credited to bank account through RTGS/NEFT for which banker's name & address, A/C number, IFSC code, Branch code etc. are to be mentioned clearly in the Bill (in triplicate).

## 7. Period of Contract

The contract for valuation work will remain valid for a period of two (2) years subject to an extension of three (3) months on the same rate, terms and conditions. HDC cannot give guarantee of work during the currency of contract including extension period. HDC reserves the right to assign no work in case of no requirement.

## 8. Breach & Termination

If there is any breach of contract on the part of successful valuer, trustees reserve the right to initiate appropriate action for termination of contract and business banning.
