- (1) The intending bidder must have successfully completed **supply work of stone chips / stone ballast / stone boulder or have completed Construction and / or Maintenance Work and/or any combination of the above works involving stone chips/stone ballast / stone boulder (only the value of supply of stone chips / stone ballast will be considered) during the last 7(SEVEN) years** ending the last day of month previous to the one in which applications are invited and minimum value of the completed works should comply with either of the following stipulations as given below :-
- Either** (a) Three completed works each costing not less than 40 % of the estimated amount put to tender.

Or (c) One completed work costing not less than 80% of the estimated amount put to tender.
2. The Average Annual Financial Turnover of the bidding firm during the last three years, ending on **31-03-2018**, should be at least **30%** of the estimated amount put to tender.
3. Work experience as a sub contractor or supply contractor **shall not be** considered as the requisite qualification.
