### 1. <u>TENDER DOCUMENTS</u>

### 1. ELIGIBILITY CRITERIA OF THE BIDDERS

Manufacturers or their Authorized Agents/Dealers/Distributor/Stockiest: -

Following documents (Photocopy) for meeting the pre-qualification criteria should be uploaded along with offer otherwise their offer may be rejected:-

- i) Having experience in successfully executing supply of similar items to Govt., PSU or Public / Private Organization during last 2 years ending 31<sup>st</sup> May 2019 for which documentary evidence must be substantiated by uploading any one or more of the following set of documents:
  - a. Purchase Order along with respective GRN/Receipted Challan.
  - b. Purchase Order along with respective Supply Challan duly accepted inspected and passed.

### 2. PRICE BID

### 8. <u>EXEMPTION FROM PAYMENT OF EARNEST MONEY</u>

### 12. <u>AMENDMENT OF TENDER DOCUMENTS</u>

- a. At any time prior to the deadline for submission of tenders, the Materials Manager for any reason whether at his own initiative or in response to a clarification required by a prospective tenderer may modify the Tender Documents.

- c. ### 13. <u>SPECIAL INSTRUCTION</u>:

- i) In a tender, either the Indian agent on behalf the principal/O.E.M or Principal/O.E.M itself can bid but both can't bid simultaneously for the same item/Product in the same tender.
- ii) If an agent submits bid on behalf the principal/O.E.M the same agent shall not submit a bid on behalf of another principal/O.E.M in the same tender for the same item/product.
- 14. Rates are to be quoted only against respective item as shown in PRICE BID.

### 15. <u>OPENING OF TENDERS</u>

- i. The tender will be opened online. Tenderers can see the Technical and price CST in their login once it is opened.
- ii. To assist in the examination, evaluation and comparison of tenders, Materials Manager may, at his discretion, ask the tenderer for a clarification of their offer. All responses to requests for clarification shall be in writing and **no change** in the price or substance of the tender shall be permitted.
- iii. The technical bids will be evaluated by the Kolkata Port Trust and only those offers which are substantially responsive to the specifications will be short listed. Further processing, discussion, etc. will be held only with the short listed tenderers.
- iv. The Earnest Money Deposit and the price bid of other tenders, (those tenderers whose technical bid is not substantially responsive to the specification) will be retained by the Kolkata Port Trust and will be returned after the finalization of the tender.

### 16. NON-RESPONSIVE BIDDER: An offer shall be considered non-responsive if the offer is:

Notwithstanding anything herein contained it is expressly agreed that the price/prices quoted in this tender is/are based on the tariff value/values and the rate/rates of Customs/ruling, on the opening date of tender and that if any increase in either tariff value or rates of Customs Duty shall be in force on the due date for delivery and shall effect any increase or decrease in the total amount of Customs Duty payable on any goods to be supplied hereunder on the said date for delivery, then the price of the said goods shall be increased or decreased by the increased or decreased amount of Duty so payable.
- 22. The Materials Manager does not bind himself to accept lowest of any tender or assign any reason for non-acceptance. He also reserves to himself the right to accept any tender in part or in whole.
- **23.** The Trustees will not recognize any assignment or endorsement in favour of third parties of any order arising out of this tender other than the authorized dealer/distributor/accredited agents in respect of any payment due by the Trustees against any such order.
- 24. If delivery of material is not made within the time undertaken, the order may be cancelled without notice and procurement of materials will be made from market at the **risk and cost of the defaulting supplier/s**.
- 25. Unless otherwise mentioned all offers will be considered for **immediate delivery ex-stock**, time being the essence of the contract in this respect.
- 26. Unit of price must be as specified in the tender, but if it becomes necessary to quote by weight instead of number approximate weight per no. must be quoted.
- 27. Any default in the supply or failure to deliver an approved quality within the time stipulated may involve purchase of the whole or any portion of the supply remaining undelivered or unapproved from another source at the risk and expenses of the supplier.
- **28.** All parties quoting should state clearly in bold letters the % of taxes and duties GST. etc. that will be charged against any item as guidance at the time of placing order.

### 29. L. D. Clause –

- i. If the supplier fails to complete the supply within the scheduled delivery period or such extension thereof, the supplier shall pay, as compensation and not as a penalty, Liquidated Damages to the Trustees @ ½% of the basic value of the delayed portion of supply, for every week or part thereof, (part of the week being treated as a full week) provided always that the amount of such compensation shall not exceed @5% of the basic value of contract. GST on L.D. amount at the prevailing rate (presently @18%) will be levied.
- ii. Without prejudice to any of their legal rights, the Trustees shall have the power to recover the said amount of compensation / damage from money due or, likely to become due to the supplier. The payment or, deduction of such damages shall not relieve the supplier from his obligations to complete any other liabilities and obligations under the contract.
- 30. Rate of GST in full may be stated as KoPT does not furnish 'C' or 'D' form.
- **31.** Conditional discount: Evaluation of tenders will not be made on conditional discount if any offered by the firm/s.
- **32. JURISDICTION:** The contract shall be governed by all relevant Indian Acts applicable only within the jurisdiction of the High Court at Calcutta.
- **33.** <u>ARBITRATION</u>: For the instant tender no Arbitration will be permissible. In case of disputes the decision of the Chief Mechanical Engineer will be final and binding.
- **34. <u>PAYMENTS TERMS</u>:** Preferably within 30 days from the date of supply (both dates being inclusive) on submission of clear bill along with Bank A/C particulars supported with GRN along with other documents as required for processing the bill for payment through ECS.
- 35. <u>Delivery Time:</u> To be completed within 45 days from the date of placement of work order.
- **36.** <u>**Delivery Place:**</u> Materials are to be supplied at KoPT main stores.
- 37. <u>**BID CURRENCY</u>**: Price shall be quoted in I.N.R only.</u>
- **38.** <u>**Guarantee/Warranty:**</u> If not otherwise stated elsewhere, supplied store is to guaranteed against any manufacturing defect for a period of 12 months from the date of installation or for 18 months from the date of supply whichever is earlier and is to be replaced free of cost in the event of development of such defect within such period.
- **39.** The trustees also reserve to themselves the right to cancel the contract either in whole or in part at any time if supply is not made in terms of the order.
- **40. LICENCES AND PERMITS:** The contractor shall be liable for obtaining all licenses and permits with respect to the goods supplied by him. Arrangements for **Dock Permit etc.** as necessary for direct delivery at stores is to be made by the supplier at their own initiative for which necessary assistance will be extended. The Dock Permit will be provided by KoPT free of cost.
- 41. Test Certificate (T.C.) from MMD/IRS/DGS/EC/any classification society as applicable and BIS certificate where applicable is to be provided.
- 42. If conditions above are not strictly complied with, the tender may not be considered. The tender will not be extended under any situation.
- 43. Manufacturer T.C. & G.C. must be provided with the supply.
- 44. The single qualified bidder against the first invitation of tender, if participates in the second or subsequent invitation, will have the option to have the EMD already furnished to count for the second or subsequent invitation, provided the validity of the Banker's Cheque/Demand Draft/Pay Order is suitably extended by the party, where applicable. However, in case of upward revision of the estimated cost in the second or subsequent invitations of bids, the party will be required to submit the difference of EMD.

- **45. - 47. Change in law clause

- Any new statutory levies, taxes, duties, cess, etc. imposed by the Central / State / local authorities by way of fresh notification subsequent to the issue of work Order / Purchase Order, but within the stipulated delivery period shall be paid extra.
