Sealed quotation are invited for Annual Maintenance of Five (5) numbers of Aqua Guard water purifier installed at different location of Administration Division, Haldia Dock Complex.

Terms & Conditions of contract

- Contract shall be for a period for two years from the date of receipt of the order.
- Payment shall be made in 4 equal instalments of the total contract value, each
 after completion of every 6 months maintenance service contract period,
 within 30 days from submission of clear bills by the contractor, subject to
 deduction, if any.
- 3. The maintenance contract of the 5 (Five) Nos. water purifier machines installed at different location of Administration Division, Haldia Dock Complex will include the following:
 - a) Cheeking, cleaning and servicing of each water purifier machine at least at an interval of 3 months or at a more frequent interval, as pr necessity.
 - b) Free replacement of Candle Filters of each machine, once in a year.
 - c) Free replacement of Carbon Filters of each machine, once in a year.
 - d) Free replacement of UV lamp, PCB, SV, Switch, etc. as and when required, during currency of the maintenance contract.
 - e) Any other requirement to ensure steady flow of purified water upto desired level.
- 4. Quotations are to be submitted for maintenance contract of all the two types of water purifier machines mentioned above. However, separate quotations are to be submitted for the maintenance contract of each of the two different types of water purifiers, in the enclosed formats. Evaluation will be

- done on the total quoted rate of the two different types of water purifiers taken together, on lowest collective/ total rate basis.
- 5. Service report (preventive or breakdown maintenance) of each machine has to be submitted by the contractor at the office of Sr. Dy Manager (Admn.), Haldia Dock Complex, Jawaher Tower, Annex Building, Haldia Township, Pin-721607 for inspection and certification of necessary payments.
- 6. Gate pass for the service personnel will be issued free of cost as per necessity.

The sealed quotations should reach the office of Sr. Dy. Manager, Administration within 1 PM of 30.06.2015 and the same will be opened on same day at 3.00 PM where you/your representative may be present.
