## TRADE CIRCULAR

Two nos. of new Road Weighbridges have been installed inside dock in addition to the earlier two Road weighbridges for weighment of bulk/ breakbulk & container carrying vehicles. The said weighbridges are ready for rendering weighment services w.e.f. 06.06.2015 (afternoon). The weighbridges are located near the '0' Gate (Western side) and on the Tippler Road near the ISPHL Rail Gate (Eastern side). The same will be operated & maintained by a contractor, M/s. Uma Corporation, appointed by KoPT.

For availing weighment services at these two new weighbridges, the existing procedure of the earlier two HDC weighbridges would apply. Importers, Exporters and Clearing & Forwarding Agents who are interested to avail the facilities of the weighbridges installed by HDC would have to open a Security Deposit Rs. 25,000/- for Dry Bulk cargo and Rs. 5,000/- for Container cargo with the Finance Division of HDC. The users who are already having Security Deposit need not open fresh deposits as the existing Security Deposit would make them eligible to avail weighment services at these two new weighbridges.

The weighment charges will be levied as per the provisions in the Scale of Rates and the user would have to pay total charges, accrued on daily basis, at the G.C. Berth cash counter on the next working day.

All concerned are requested to be guided accordingly.
