CIRCULAR

Sub: Facility for direct delivery of import FCL containers from the Docks/Container Terminal of HDC.

Reference Circulars No. MTO/G/11-H/1269 dated 19.05.2015 and MTO/G/11-H/1538 dated 11.06.2015, and MTO/G/11H/1889 dated 15.07.2015, for the FY 2015-16 the compulsory removal of import load containers of the Customs' ACP Clients and the Volume Importers, as stated below, shall be exempted for the period as shown against each for these categories below.

1. Customs' ACP Clients: 7 days after the date of landing.

The Customs' ACP Clients, as may appear in the list approved and notified by Customs from time to time, will have to apply to the port for the exemption from compulsory removal of import load containers to CFS for the FY 2015-16 and such exemption shall remain valid only for the period of validity of the ACP Client status as may be specified in the aforesaid Customs' list.

2. Volume Importers: 7 days after the date of landing.

The following Volume Importers have handled more than 750 TEUs of containers at Haldia Dock Complex during the FY 2014-15 and are accordingly exempted from compulsory removal of import load containers for the FY 2015-16, if so intended by them,

NOTE: The containers carrying Scrap Materials shall not qualify for the above said exemptions and such containers shall have to be removed to off-dock CFS.
