## **Trade Circular**

For tracking and viewing the movement of containers between the Ports and Container Freight Station/Inland Container Depots, a need was felt by the Ministry of Shipping (MoS) to develop a Logistics Data Bank (LDB) which would integrate the information available with various agencies across the supply chain to provide a near real time information within a single window. DMICDC Logistics Data Services Ltd. (DLDSL) has been engaged for providing the LDB Service. The service will be available in the LDB Web Portal of DLDSL. A Mandatory User Charge (MUC) of Rs. 145/- plus applicable GST per container, which has been approved by the Tariff Authority for Major Port, is to be collected from the Shipping Lines/ MLOs for the LDB Service. The above rate is valid upto 31.03.2019. The MUC will be collected for all containers other than transshipment and coastal Container at the rate mentioned above.

The stakeholders are hereby informed that the LDB Service will be available from 01.12.2018.
