**Sub :** Extension of performance as well as productivity/incentive norms for handling of Edible Oil through Pipeline at HDC.


**Ref :** This Office earlier circular no. MTO/G/104/Pt.IX/2286 dated 12.07.2018 (copy enclosed)

Sub.: Introduction of Performance as well as Productivity/Incentive norms for handling Edible Oil through pipeline at HDC.

In order to improve the average productivity of Crude Palm Oil, RBD Palm Oil and Soyabean oil cargo at HDC, a Performance as well as Productivity/Incentives norms for handling of edible oil through pipeline was introduced w.e.f. 01.08.2017 for a period of 1 year with review thereafter vide Trade Circular No. MTO/G/104/Pt. IX/1901 dated June 19, 2017.
