NOTICE

There is a forecast of a very severe cyclonic storm "YAAS" to pass over the coastal areas of West Bengal on 26.05.2021 with high wind speed. In order to protect men, machineries and Port property from the cyclonic storm, it is hereby advised to all MHC Operators, Berth Operators, Handling agents, Tank operators, Contractors and all other Stakeholders to secure their equipment/machineries well before arrival of the storm. All the Importers and Exporters are advised to cover up their cargo with tarpaulin and secure the same with sandbags. As per present indication, the condition of the weather is likely to deteriorate from 18:00 hrs. on 25.05.2021 and is expected to remain turbulent till 06:00 hrs. on 27.05.2021.

In view of the above, the following activities must be strictly followed;

- All cargo operations in the Dock as well as in the Oil Jetties to be kept suspended from 14:00 hrs. on 25.05.2021 till 06:00 hrs. on 27.05.2021.
- Receipt and dispatch of the rakes shall be kept suspended from 06:00 hrs. and 22:00 hrs. on 25.05.2021 respectively.
- Lashing / securing of equipment such as RMQCs, RTYGCs, RSTs, Shiploaders, Ship Unloaders, Payloaders, Bulldozers, Excavator, Trailers, Dumpers etc. to be undertaken from 22:00 hrs. on 24.05.2021 phase-wise and to be completed by 18:00 hrs. on 25.05.2021.
- All the gates of the Dock (excepting the Main Gate, CJP Gate and the HFTPL Gate) shall be kept closed from 22:00 hrs. on 25.05.2021 and entry / exit of personnel as well as vehicles will not be allowed to / from the Dock except for emergency purpose. Special permission shall be given to the personnel / vehicles, who will remain inside the Dock for emergency purpose.
- The C&F agents / Transporters must take out all cargo vehicles out of the Dock by 18:00 hrs. on 25.05.2021.

Note: The above timings are tentative and final timings shall be intimated later on.
