Trade Circular

Sub: Extension of scheme of additional remissions against Vessel Related Charges (VRC) and Cargo Related Charges (CRC) for lighterage cargo from 01.12.2021 to 31.03.2022.

As approved by the competent authority of SMP, Kolkata, the following additional remissions on VRC and CRC on lighterage cargo are being made applicable from 01.12.2021 to 31.03.2022 to incentivize mobilization of additional cargo through lighterage operation at Anchorages of SMP, Kolkata:

- (i) Remission of 75% on Railway Haulage Charges, for importers mobilizing 4.5 lakhs MT of lighterage cargo. The assessment of quantity, under the facility, shall be calculated at the end of the current fiscal for determining qualification for the waivers. The rebate will be restricted to cargo imported between 01.12.2021 to 31.03.2022, by port users for use in their own manufacturing units only.
- (ii) Waiver of 50% Anchorage Charge in all anchorages of SMP, Kolkata against vessels undertaking lighterage operation. The discount will be applicable for Port users handling more than 4.5 lakhs MT of lighterage cargo as stated in (i) above.
- (iii) The requirement of loading/unloading of 1 lakh MT for all category of dry bulk vessels, in order to qualify for rebates against Vessel Related Charges as mandated in Trade Circular No. Tfc./G 252/SOR dated 08.06.2021 has been dispensed.
