Sub-: Filling up of the post of Director, Marine Department by absorption through composite method in Kolkata Port Trust – applications invited.

The post of Director, Marine Department in the rank of Head of Department which has fallen vacant w.e.f 01.01.2020 is to be filled up by Absorption through Composite Method from the officers of Major Port Trusts, fulfilling the eligibility criteria for the concerned post, as per the **Annexure-I.**

- 2.
