#### FINAL ORDER

The matter is taken up today for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust) applicant, herein, that all along SMP,K is the owner of the of Quarter No 1 Block no.19 at Hide Road Mazdoor Line. The said quarter was under lock and key since 24.11.2000. On or about 07.12.2000, one Sri Sonai, the Opposite Party hereinafter referred to as O.P. forcibly occupied the above quarters by breaking open the padlock and has since been living in the quarters unauthorisedly. An application was filed by SMPK on 12.03.2001, praying for eviction of O.P.

This Forum on having the information of such unauthorised occupation issued a Notice to Show Cause under Section 4 of the Public Premises (Eviction of Unauthorised Occupant) Act, 1971 (hereinafter referred to as The Act) on 09.05.2022. The said Show Cause notice along with the order dated 09.05.2022 were sent through "Speed Post". The envelope, was returned with the remark "Addressee moved". The said order was also sent through Process Server. It is seen from the report of the Process Server dated 20.05.2022, that O.P. refused to take the order. However, due affixation was also made in the conspicuous part of the premises for notice to all concerned. I am satisfied with the service of notice.

- (e) That O.P.'s occupation is unauthorised in all respect and O.P. has failed to make out any case in support of his occupation.

Accordingly, Department is directed to draw up a formal order of eviction u/s5 of the Act and Rules made thereunder against O.P., giving 15 days time to all the occupants of the quarters in question or whoever may be
