
WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that Shri Pandey, Qtrs.31 Block No. D/1 at BISN Mazdoor Line P.S. South Port Police Station. Kolkata- 700 023 is in unauthorized occupation of the Public Premises specified in the Schedule below:

REASONS

- 1) That no reply to the Show Cause notice is filed by O.P.
- 2) That nothing has been shown in support of O.P.'s occupation into the public premises.
- 3) That no evidence has been laid to support the possession of O.P. as "authorized possession/ occupation".
- 4) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question.
- That O.P.'s occupation is unauthorized in all respect and O.P has failed to make out any case in support of his occupation.

In the event of refusal or failure to comply with this order within the period specified above the said Shri Pandey, Qtrs.31 Block No. D/1 at BISN Mazdoor Line P.S. South Port Police Station. Kolkata- 700 023 and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

FINAL ORDER

The matter is taken up today for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust) applicant, herein, that all along SMP,K is the owner of the of Quarter No 31 Block no.D/1 at BISN Mazdoor Road. The said quarter was under lock and key since 03.12.1997. One Sri Pandey, the Opposite Party hereinafter referred to as O.P. forcibly occupied the above quarters by breaking open the padlock and has since been living in the quarters unauthorisedly. An application was filed by SMPK on 03.06.1998, praying for eviction of O.P. Forum on the basis of the information issued a Notice to Show Cause under Section 4 of the Public Premises (Eviction of Unauthorised Occupant) Act, 1971 (hereinafter referred to as The Act) on 14.10.2022. The said Show Cause notice along with the order dated 14.10.2022 were sent through "Speed Post". The envelope, was returned with the remark "Insufficent address". The said order was also sent through Process Server. It is seen from the report of the Process Server dated 26.10.2022, that O.P. refused to accept the order. However, due affixation was also made in the conspicuous part of the premises for notice to all concerned. Inspite of having knowledge of the pending proceedings the O.P. nor anyone interested in the said property appeared before the Forum to place their submissions. I am satisfied with the service of notice.

left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have no reason to disbelief on the statements made by SMP,K before the Forum. Accordingly the order of eviction is issued on the following grounds/ reasons;

- (a) That no Reply to the Show Cause has been filed byO.P. or anyone else
- (b) That nothing has been shown in support of O.P.'s occupation into the premises;
- (c) That no evidence has been laid to support the possession of O.P. as "authorised possession/occupation"
- (d) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question;
- (e) That O.P.'s occupation is unauthorised in all respect and O.P. has failed to make out any case in support of his occupation.

Accordingly, Department is directed to draw up a formal order of eviction u/s5 of the Act and Rules made thereunder against O.P., giving 15 days time to all the occupants of the quarters in question or whoever may be in occupation are liable to be evicted by this Order and SMP,K is entitled to claim damages for unauthorised use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.
