As approved by the Board of Major Port Authority for Syama Prasad Mookerjee Port, Kolkata, on 30.05.2022 vide reso No. R/109/KDS/MRN/3/05/2022 and on 18.05.2023 vide reso No. R/478/KDS/MRN/3/05/2023, the following will be applicable with immediate effect:

STANDARD OPERATING PROCEDURE FOR CARRYING OUT DREDGING / DE-SILTING OPERATIONS IN RIVER HUGLI AND BHAGIRATHI WITHIN PORT LIMITS / JURISDICTION OF SMPK TO EXTRACT SAND / SILT / EARTH / SOIL FOR THE PURPOSE OF THEIR MAINTENANCE, UPKEEP AND DISASTER MANAGEMENT AS WELL AS FOR THE PURPOSE OF EXTRACTING FILLING MATERIALS FOR ALL LINEAR PROJECTS

(Passed vide Board Resolution no. R/415/KDS/MRN/3/03/2023 in meeting dated 30<sup>th</sup> March 2023)

The following Standard Operating Procedure (SOP) is adopted by SMP, Kolkata for grant of approval / permission for carrying out dredging / de-silting operations in River Hugli & Bhagirathi within port limits / jurisdiction of SMPK to extract sand / silt / earth / soil for the purpose of maintaining navigable channels and their upkeep, for disaster management and for the purpose of filling materials for all linear projects:-

- (i) DMD will be the nodal officer of SMPK for grant of permission for sand / silt excavation for dredging / desilting / other purposes in the River Hugli.
- (ii) The applications (in quadruplicate and enclosing 4 original copies of SMPK hydrographic chart of the locality, marking out the area selected and the stacking yard ashore identified by the applicant) are to be addressed to the Director, Marine Department.
- (iii) The proposed area of excavation will be examined by the Hydraulic Study Department from the hydraulic point of view. After due examination, CHE will issue a "No Objection Certificate" for the proposed area, or allocate an alternate stretch / area of the river nearby for dredging / de-silting / extraction of sand / silt / earth / soil, if the proposed site is found unsuitable. If no nearby site is found suitable by CHE, the application will be denied.
- (iv) The Estate Division will examine and issue "No Objection Certificate" for the land parcel to be used as stacking yard as shown in the chart, after examining whether the same belongs to SMPK.
- (v) The proposed area of excavation (or an alternate area allocated by the CHE, as the case may be) will also be examined by the Marine Department keeping in mind the navigational point of view. After due examination, the authorised officer will issue "No Objection Certificate" for the proposed or alternate stretch / area of the river for dredging / de-silting / extraction of sand / silt / earth / soil.
- (vi) Subject to clearances as stated under (ii), (iii), & (iv) above, the applicant will pay the following charges:
  - (a) Hydrographic survey charges of the area (both pre and post excavation) upfront, taken together, at the rate approved by the Board vide Reso No. R/109/KDS/MRN/3/05/2022 dated 30.05.2022, or as amended from time to time;
  - (b) Impact Assessment Charges (IAC) for silt excavation (including departmental charges @ 19.25% and contingency @ 3% on the base amount of IAC) at the rate approved by the Board vide Reso No. R/478/KDS/MRN/3/05/2023 dated 18.05.2023 or as amended from time to time;

- (c) An amount equivalent to Impact Assessment Fee is to be kept as Security Deposit in addition to the charges as stated above (in the form of a Bank Guarantee) during pendency of the dredging / desilting operations. This amount will be returned to the applicant after his permitted tenure of dredging / desilting operations is over.
- (vii) On receipt of necessary payment and on completion of the pre-dredging survey work, permission will be granted by the Director, Marine Department after obtaining approval of Chairman with the following conditions:-
  - (a) An undertaking to be submitted by the applicant that they will neither excavate / dredge outside the permitted area nor exceed the permitted quantum of extraction of sand / silt / earth / soil.
  - (b) *Penalty Clause:* The Security Deposit will be forfeited if at anytime during the pendency of the contract, it is found that they have violated clause (vii) (a) above.
  - (c) An undertaking to be submitted by the applicant that they will comply with all existing environmental and other state government regulations.
  - (d) An undertaking to be submitted by the applicant that they will take all necessary clearances from WBMDTCL / concerned DLLRO of the district for transportation of extracted sand / silt / earth / soil.
- (viii) All such permissions granted by the Chairman during each quarter of the calendar year will be subsequently placed before the Board for ratification.
