



The matter is taken up today for final disposal. The factual matrix is required to be put forward in a nutshell in order to link up the chain of events leading to this proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata [erstwhile Kolkata Port Trust/KoPT], hereinafter referred to as SMPK, the Applicant herein, that Port property being covered space msg.5.946 sq.m. or thereabout on the top floor of SMPK's building being premises No.P-221/2, Strand Bank Road, situated on the west side of the Strand Road in the presidency town of Kolkata comprised under occupation No.CG-176/1 was allotted to Estate Nandalal Vyas, on the strength of a monthly lease, executed and registered by and between the parties on certain terms and conditions and O.P. violated the condition of such lease by defaulting in payment of rental dues to SMPK and also by way of unauthorized parting with possession of the subject premises to third parties. It is the case of SMPK that in view of such breaches committed by O.P, SMPK served notice of ejectment to O.P. dated 24.03.2005, demanding possession of the public premises from O.P. and it is argued that O.P. has no authority under law to occupy the public premises after expiry of the period as mentioned in the said notice of ejectment.

This Forum of Law formed its opinion to proceed against O.P. under the relevant provision of the Act and issued Show Cause Notice u/s.4 of the Act on 02.08.2019 vide Order No.14 dated 29.07.2019 (for adjudication of the prayer of SMPK for order of eviction) and two Show Cause Notices u/s.7, both dated 02.08.2019 vide Order No.14 dated 29.07.2019(for damages and recovery of arrear rental dues) as per Rule, calling upon O.P. to show cause on or before 26.08.2019 etc. Such notice/s u/s.4 and 7 were affixed on the property as per reports of the process server dated 20.10.2022 and 15.11.2022. The Notice/s sent by post were repeatedly returned undelivered to the forum with remarks of the Postal Department as "no such Company in this address" on

As no one appeared on behalf of O.P. to represent their case, a notice was also published in English Daily "The Statesman" on 13.12.2022 for the purpose of effecting service of notice to all concerned interested in the property in question. In spite of service of notice to all concerned, nobody appeared before me at the date scheduled for hearing etc. and nobody from O.P's side filed any objection or reply to the Show Cause Notice u/s.4 & 7 of the Act. In such a scenario, I think effective service of notice has already been made as per mandate of the statute by affixation on the premises and through press publication. Likewise, I find that SMPK has made out an arguable claim against O.P., founded with sound reasoning, regarding the damages/compensation to be paid for unauthorised occupation. As such, I must say that Rs.1,826.73(Rupees One thousand eight hundred twenty six and paise seventy three only) as claimed by the Port Authority as damages in relation to the subject premises in question, is correctly payable by O.P. for the period 26.04.2005 to 31.07.2005 (both days inclusive) and it is hereby ordered that O.P. shall also make payment of the aforesaid sum to SMPK by 1.4.06.22The said damages shall attract compound interest @ 7.50 % per annum, which is the current rate of interest as per the Interest Act, 1978 (as gathered by me from the official website of the State Bank of India) from the date of incurrence of liability, till the liquidation of the same, as per the adjustment of payments, if any made so far by O.P., in terms of SMPK's books of accounts. I sign the formal orders u/s 7 of the Act.

I make it clear that SMPK is entitled to claim damages against O.P. for unauthorized use and occupation of the public premises right upto the date of recovery of clear, vacant and unencumbered possession of the same in accordance with Law, and as such the liability of O.P. to pay damages extends beyond 31.07.2005 as well, till such time the possession of the premises continues to be under the unauthorised occupation with the O.P. SMPK is directed to submit a statement comprising details of its calculation of damages after 31.07.2005, indicating there-in, the details of the rate of such charges, and the period of the damages (i.e. till the date of taking over of possession) together with the basis on which such charges are claimed against O.P., for my consideration for the purpose of assessment of such damages as per Rule made under the Act.


