TRADE CIRCULAR

Sub: Trade Promotional Schemes applicable after coming into effect of First Scale of Rates of Syama Prasad Mookerjee Port, Kolkata (SMPK) under the Major Port Authorities Act, 2021.

The Board of SMPK has approved its First Scale of Rates framed under MPA Act, 2021 and notified the same in Part-II Extraordinary in the State Gazette on September 30, 2023. Revised rates will be implemented after expiry of 30 days from the date of aforesaid notification i.e., from October 31, 2023

- 2. The Board of SMPK has further approved for implementation of some Trade Promotional Schemes at HDC and KDS after coming into effect of said Scale of Rates. The details of Trade Promotional Schemes to be effective w.e.f. October 31, 2023 is furnished in **Annexure I** enclosed herewith.
