CIRCULAR

Regarding Periodical Medical Examination (PME) of the dock workers engaged by Port Users, further to this office letter No. Tfc/GZZY-658/DS dated 26.10.2018, this is to inform you that for the purpose of making the process of undergoing the PME by Private Dock Workers easier, it has been decided in the 190th meeting of the Safety Committee for the Port of Kolkata held on 04.12.2018 that necessary tests/examinations in for PME may be done outside the Centenary Hospital (as per Annexure I). However, certificates in this regard would be issued from the end of Dr. Bhowmick after verification of all the reports of tests/examinations by him.

In this regard, it may be mentioned that at present, no DGFASLI empanelled doctor is available at Kolkata/Haldia for carrying out medical examination of dock workers, but some DGFASLI empanelled doctors in Mumbai have portable facilities for carrying out medical examination of dock workers at any place (Kolkata/Haldia). The list of such empanelled doctors is available on DGFASLI website (www.dgfasli.nic.in). So, the Port Users can also contact with such empanelled doctors for carrying out of medical examination of dock workers.

2. As you are aware, in terms of Dock Workers (Safety, Health & Welfare) Regulations, 1990, the PME of Dock Workers is to be carried out once in every 2 years upto the age of 40 and once in a year, thereafter.

For ensuring a safe working environment in the docks as well as for fulfilling such statutory obligations in the matter, it has been decided that the PME Certificate for Dock Workers will also have to be submitted mandatorily while making applications for Dock Permits along with other necessary documents. This comes into effect from **01.04.2019**.
