That the notice demanding possession from you as issued from KoPT's end vi) dated 25.7.2005 has its full force of law and as such the notice is valid, lawful and binding upon the parties...

I am satisfied with the service of notice to all concerned after affixation of the notice/order on the property in question as per provision of the Public Premises Act as contained in Section-4 of the Act. In course of hearing KoPT's representative strongly argued that O.P. had lost its authority to occupy the public premises after expiry of the period of lease in question, which expired long back on and from 27.10.1994. It would not be out of scope to mention that it is the specific case of KoPT that a lease for 30 years without any option for renewal with effect from 27.10.1964 was granted to O.P. with certain terms and conditions as embodied in the said lease. It is argued with great emphasis that O.P's authority to occupy the public premises has already been ceased and O.P. is no longer an authorized occupier as per definition of "unauthorized occupation" under the P.P. Act. As there is no reply to the Show Cause u/s.4 of the Act in spite of repeated chances to O.P. and the O.P. has failed to appear before me in spite of sufficient service of notice/order through affixation on property, I have no other alternative but to allow the prayer of Kolkata Port Trust (KoPT) as contained in its petition as filed on 14.6.2006. In fact I have no other alternative but to issue order of eviction against O.P. under the following grounds/reasons.

That the O.P. has failed and neglected to file its reply to Show Cause u/s.4 of the Act in spite of repeated chances.

ACCORDINGLY, Department is directed to draw up formal order of eviction u/s.5 of the Act as per Rule made there under, giving 15 days time to O.P. and any person/s whoever may be in occupation to vacate the Port property in question.
