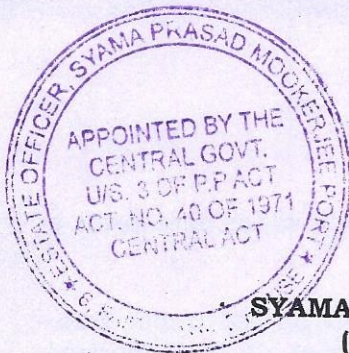

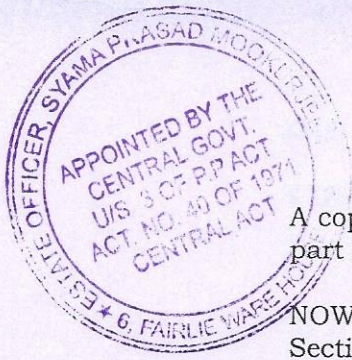
WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that M/s R.K Mishra & Co., 210, Upper Chitpore Road, Kolkata-700003 is in unauthorized occupation of the Public Premises specified in the Schedule below:

REASONS

- 1) That O.P or any other person interested in the property has failed to file any reply to the Show Cause Notice/s U/S 4 & 7 of the Act inspite of sufficient chances being provided to them.
- 2) That O.P has erected unauthorised structures on the SMP, Kolkata's land and also parted with possession of the subject premises without having any authority under law.
- 3) That the O.P has failed to bear any witness or adduce any evidence in support of their occupation as "authorised occupation".

FINAL ORDER

The matter is taken up today for final disposal. It is the case of Syama Prasad Mookerjee Port, Kolkata [erstwhile Kolkata Port Trust], hereinafter referred to as SMP, Kolkata, Applicant herein, that a month to month lease was granted to **M/s R.K Mishra & Co (O.P)**, on certain terms and conditions in respect of public premises being land measuring 28.986 sq.m(under Plate No.SB-506), two asbestos roofed rooms measuring about 11.15 Sq.m& 2.97 sq.m and also a veranda space msg. about 3.99 sq.m (under Plate No.CG-102/5) all are situated at Bichalighat, Bagbazar, Kolkata, and allegation levelled by SMP, Kolkata against the O.P is that O.P violated the condition of such tenancy by way of not making the payment of rental dues along with accrued interest and other charges of SMP, Kolkata, erecting unauthorised structures and also by way of parting with possession of the Trustees land without having any authority under law.

It is the case of SMP, Kolkata that in view of such breaches SMP, Kolkata has issued two No's of Notice/s to Quit, one dated 28.07.1982 for the Plots under (Plate No. SB-506) and another one dated 31.01.1983 for the plots under (Plate No.CG-102/5). It is argued on behalf of SMP, Kolkata that O.P has no authority under law to occupy the said public premises after expiry of the period as mentioned in both the notice to quit dated 28.07.1982 and 31.01.1983 and O.P is liable to pay damages for unauthorised enjoyment of the Port property in question.

This Forum formed its opinion to proceed against O.P under the relevant provisions of the Act and issued Show Cause Notice U/S 4 of the Act (for adjudication of the prayer for order of eviction etc.) and Show Cause Notice U/S-7(for adjudication of the prayer for recovery of arrear rental dues & damages etc.) all dated 01.10.2020 (vide

After issuance of the aforesaid notice, O.P. did not appear before the Forum for giving reply to the Show Cause. However, the record depicts that such Notice had been sent to O.P both by hand and Speed Post as per addresses available on record.

It reveals from the reports of the Process Server both dated 09.03.2021 that Show Cause Notice/s u/s 4 & 7 and subsequent Order were not served upon O.P. as the address was not found. The Postal Services to the recorded address of O.P. also returned undelivered to the Forum with the endorsement 'Addressee not known'. To give chances to O.P as per the Principles of Natural justice, the Forum made several attempts of service of its subsequent orders and when no response was received from O.P's end, this Forum vide its Order dated 01.03.2021 directed SMP, Kolkata to file other alternative addresses of O.P. if available with them. When SMP, Kolkata informed that no other alternative addresses were available with them, a publication was made in the classified column of Times of India (Kolkata) on 27.07.2021 fixing the ultimate date of O.P's appearance on 16.08.2021. Finally as the O.P failed to appear on 16.08.2021 the final Order was reserved in the matter. Now this Forum has decided to adjudicate the matter ex-parte.

As no one from O.P's side appears and no reply to the Show Cause Notice u/s 4 & 7 of the Act has been filed as yet, I have no bar to accept the claim of SMP, Kolkata on account of unauthorised occupation of O.P into the Public Premises in question. I think that it is a fit case for issuing Order of eviction u/s 5 of the Act on the following grounds:-

1) That O.P or any other person interested in the property has failed to file any reply to the Show Cause Notice/s U/S

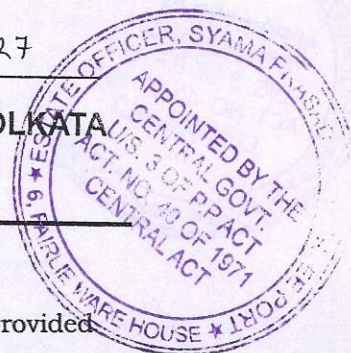

ACCORDINGLY, Department is directed to draw up formal order of eviction u/s.5 of the Act as per Rule made there under, giving 15 days time to O.Ps' and any person/s whoever may be in occupation to vacate the premises. I make it clear that all person/s whoever may be in occupation are liable to be evicted by this order and the Port Authority is entitled to claim damages for unauthorized use and enjoyment of the property against O.Ps' in accordance with Law up to the date of recovery of possession of the same.

It is my considered view that a sum of Rs.270.39 (Rupees Two hundred Seventy and paise Thirty nine only) for Plate No.SB-506 for the period 01.07.1982 to 30.09.1982(both days inclusive) and Rs.1233.20(Rupees One Thousand Two hundred Thirty three and paise Twenty only) for the Plate CG-102/5 for the period 01.06.1982 to 31.03.1983 (both days inclusive) are due and recoverable from O.P. by the

Port authority on account of rental dues and O.P. must have to pay such dues to SMP, Kolkata on or before 14.01.2022

Such dues attract compound interest @ 6.20 % per annum, which is the current rate of interest as per the Interest Act, 1978 (as gathered by me from the official website of the State Bank of India) from the date of incurrance of liability, till the liquidation of the same, as per the adjustment of payments, if any made so far by O.P., in terms of SMP, Kolkata's books of accounts.

Likewise, I find that SMP, Kolkata has made out an arguable claim against O.P., founded with sound reasoning, regarding the damages/compensation to be paid for unauthorised occupation. As such, I must say that Rs 5,41,664.36(Rupees Five Lakh Forty one thousand Six hundred sixty four and paise Thirty six only) for the Plate No.SB-506 for the period 01.10.1982 to 08.05.2019(both days inclusive) and Rs.3,60,427.90(Rupees Three Lakh Sixty thousand Four hundred twenty seven and paise Ninety only) for Plate No.CG-102/5 for the period 01.04.1983 to 08.05.2019(both days inclusive) as claimed by the Port Authority as damages in relation to the subject premises in question, are correctly payable by O.P. and it is hereby ordered that O.P. shall also make payment of the aforesaid sum to SMP, Kolkata by The said damages shall attract compound interest @ 6.20 % per annum, which is the current rate of interest as per the Interest Act, 1978 (as gathered by me from the official website of the State Bank of India) from the date of incurrance of liability, till the liquidation of the same, as per the adjustment of payments, if any made so far by O.P., in terms of SMP, Kolkata's books of accounts. I sign the formal orders u/s 7 of the Act.

I make it clear that SMP, Kolkata is entitled to claim further damages against O.P. for unauthorized use and occupation of the public premises right upto the date of recovery of

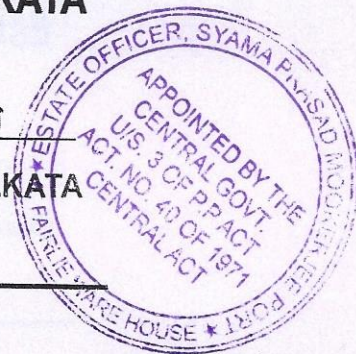



SMP, Kolkata is directed to submit a statement comprising details of its calculation of damages after 08.05.2019, indicating therein, the details of the rate of such charges, and the period of the damages (i.e. till the date of taking over of possession) together with the basis on which such charges are claimed against O.P., for my consideration for the purpose of assessment of such damages as per Rule made under the Act.

I make it clear that in the event of failure on the part of O.P. to comply with this Order, Port Authority is entitled to proceed further for execution of this order in accordance with law. All concerned are directed to act accordingly.
