



The matter is taken up today for delivering the final order. It is the case of Syama Prasad Mookerjee Port, Kolkata [earstwhile Kolkata Port Trust/ KoPT (hereinafter referred to as 'SMPK'/ 'Port Authority'), applicant herein, that Quarter No 10, Block No -I at K.F. Shipping Mazdoor Line, P.S. South Port Police Station, Kolkata- 700 023 was under lock and key of SMPK since 01.02.2001. However, one Md. Elias (hereinafter referred to as O.P. No. 1), rank outsider forcibly occupied said Quarter by breaking open SMPK's padlock on or about 13.08.2001 and since then the O.P. No 1 was living unauthorisedly in the said quarter/ public premises as an unauthorised occupant. It is further the case of SMPK that on a recent inspection it has been found that the said quarter is presently being unauthorisedly occupied by one Md. Azad (hereinafter referred to as O.P. No. 2), who is also a rank outsider into the quarter/public premises in question.

This Forum formed its opinion to proceed against both O.P. No 1 and 2 by issuing the Show Cause Notice dated 12.01.2021 (vide Order no 04 dated 14.12.2020) for adjudication of the prayer of eviction, under the relevant provisions of Public Premises (Eviction of Unauthorized Occupants) Act, 1971 (hereinafter referred to as 'the Act') and the Rules made thereunder. The O.P. no 1 & 2 were called upon as per the relevant provisions of the Act and the Rules made thereunder to appear before this forum in person or through authorized representative/s, capable to answer all material questions connected with the matter, along with the evidence which the O.P.s intends to produce in support of their case.

The said Notice was sent through 'Speed Post' to the Quarter address of the O.P., however, the notice was returned

undelivered by the Postal Department. The 'Process Server' attached with this Forum has submitted his report dated 14.01.2021 intimating failure of service of such notice due to "door closed". However, the Notice was affixed on the property in question, as per the mandate of the Act, as it appears from the said report of Process Server dated 14.01.2021. Inspite of such efforts made, the appearance of O.P. could not be procured and the efforts remained futile. Following the principles of natural justice, further attempt was made to serve such notice in terms of Order dated 01.02.2021. However, such effort also went unsuccessful as it appears from the report of 'Process Server' dated 25.02.2021 that the parties did not allow him to enter into the premises and threatened to assault him in case he makes further attempt to visit there. However, this time also the Notice was affixed on the property in question, in terms of the mandate of the Act.

Inspite of such efforts, nobody appeared before me with any authority to stay into the quarters in question. Considered the report of the Process Server dated 14.01.2021 and 25.02.2021 regarding affixation of Show Cause Notice u/s 4 of the Act on the property in question. I am satisfied with the service of notice to all concerned. No reply to the Show Cause Notice u/s 4 of the Act dated 12.01.2021 on behalf of either O.P. no 1 or O.P. no 2 has been filed. As such, I have nothing to disbelieve the statements made against both the O.P.s by the Port Authority. In fact, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority on the following grounds/reasons.

- 1. That nothing has been shown in support of either O.P's occupation into the public premises.
- That no evidence has been laid to support the possession of either O.P. as "authorized possession/occupation".

3. That mere occupation into the quarters for a period without any authority for such occupation cannot create any right over the property in question.

4. That both the O.P's occupation is unauthorized in all respect and both the O.P's have failed to make out any case in support of their occupation.

ACCORDINGLY, Department is directed to draw up formal order of eviction u/s. 5 of the Act and Rules made thereunder against O.P., giving 15 days time to all to vacate the said Quarter/ public premises. I make it clear that all the occupants of the quarters in question whoever may be in occupation are liable to be evicted by this order and Port Authority is entitled to claim damages for unauthorized use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.
