FINAL ORDER

The instant proceedings No. 1546, 1546/R and 1546/D of 2017 arise out of the applications bearing No. Lnd 14/64/04/2329 dated 04.11.2004 and Lnd 14/64 dated 03.02.2017 filed by Syama Prasad Mookerjee Port, Kolkata [erstwhile Kolkata Port Trust/ KoPT, hereinafter referred to as 'SMP, Kolkata'], the applicant herein, under the provisions of the Public Premises (Eviction of Unauthorised Occupants) Act, 1971 (hereinafter referred to as 'the Act') praying for an order of eviction and recovery of rent as well as compensation dues/mesne profit/ damages etc. along with the accrued interest in respect of the public premises, against M/s Shyam Sundar Agarwal (hereinafter referred to as O.P.).

The fact of the case in a nutshell is that the O.P. came into occupation of the port property (under Plate Nos. SB-524) as a monthly Licencee at the piece or parcel of land (common passage) measuring about 50.85 sq.m. or thereabouts situated in front of Trustees' godown No. D/5 on the South side of J.N. Ghat Cross Road, Kolkata, morefully described in the Schedule 'A' of the SMP, Kolkata's said application dated 04.11.2004, which has further been clarified vide SMP, Kolkata's application bearing no. Lnd 14/64/21/3961 dated 29.11.2021. The allegations levelled by SMP, Kolkata against the O.P are that the O.P. defaulted in making payment of the SMP, Kolkata's dues, has erected unauthorised structures on the demised premises and has parted with the possession of the premises without approval of the SMP, Kolkata authorities in clear violation of the terms and conditions of the License. It is the case of SMP, Kolkata that the O.P. had failed and neglected to quit, vacate and deliver up peaceful possession of the said premises in terms of the notice to quit dated 15.05.1993. It is the case of SMP, Kolkata that the tenancy

business, has a definite evidentiary value, unless challenged with fortified documents/evidences etc., ready to bear the test of legal scrutiny. During the course of hearing, I am given to understand by SMP, Kolkata that the rent as well as dues on account of mesne profit/compensation/ damages, charged from time to time is based on the rates notified by the Tariff Authority for Major Ports (TAMP) in the Official Gazette, which is binding on all users of the port property. Non-payment of dues by O.P. for decades is very much prominent and established, as per records submitted by SMP, Kolkata, discussed above. Hence, I have no bar to accept the claim of SMP, Kolkata on account of rent and damages/compensation/ mesne profit etc. As per law, a monthly License like the one granted to the O.P., continues only on the basis of timely payment of rent bill/s and non-payment of the same, even for a small period, is enough to vitiate the contract. Here, in the instant case, O.P. is a defaulter for decades and had never bothered to pay SMP, Kolkata. In my view, the Breach committed by the O.P. is very much well established in the facts and circumstances of the case and O.P. must have to suffer the consequences, following due applications of the tenets of law.

With regard to the other breaches of O.P., as has been alleged by SMP, Kolkata, viz. the erection of unauthorised structures on the demised premises, parting with possession of the premises without approval of the SMP, Kolkata etc., no substantial piece of evidence has been led by SMP, Kolkata, and as such it is very difficult to believe these allegations against the O.P., particularly in a situation of their absence in the proceedings.

SMP, Kolkata is directed to submit a comprehensive status report of the Public Premises in question on inspection of the property after expiry of the 15 days as aforesaid, so that necessary action can be taken for execution of the order of eviction u/s 5 of the Act, as per Rule made under the Act.

It requires mention here that SMP, Kolkata filed an application bearing no. Lnd 14/64/21/3961 dated 29.11.2021, intimating for the first time, that the subject property falls under the jurisdiction of "Posta Police Station" instead of "Jorabagan Police Station", as has wrongly been mentioned in the original application of SMP, Kolkata dated 04.11.2004. It is further been stated that the measurements of the property in question, as has been mentioned in the application dated 04.11.2004, is also wrong and requires to be modified as "50.35 sqm" in place of the wrong recording of "50.85 sqm" in the said application dated 04.11.2004. In my view, such error in the schedule is apparently an inadvertent and typographical one, which crept in the said Show Cause Notices and it deserve to be treated as such. It is my considered view that such error does not go into such deep to affect the merits of the case and is obviously not prejudicial to the rights and contentions of the parties. In my view, the specification of the property, as mentioned in the in the original application of SMP, Kolkata dated 04.11.2004, is sufficient for due identification of such property. When the boundary of the property as mentioned under schedule remains unchanged, there is no scope for any dispute regarding the identification of property. In the given facts and

I make it clear that SMP, Kolkata is entitled to claim damages against O.P. for unauthorized use and occupation of the public premises right upto the date of recovery of clear, vacant and unencumbered possession of the same in accordance with Law, and as such the liability of O.P. to pay damages extends beyond 02.02.2017 as well, till such time the possession of the premise continues to be under the unauthorized occupation with the O.P.
