
WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that **Shri Madhusudan Ghosh, Son of Late Hiralal Ghosh, J,352A, Paharpur Road, Garden Reach, Kolkata - 700 024** and also of **Hari Mohan Ghosh Road, Kolkata - 700 024** is in unauthorized occupation of the Public Premises specified in the Schedule below:

REASONS

- 1) That O.P. has failed to appear before this Forum and failed to file reply to the Show Cause Notice/s under the Act inspite of sufficient chances being given.
- 2) That the O.P. unauthorisedly parted with the possession of the premises to rank outsiders, in clear violation of the conditions of the lease in question.
- 3) That the notice to quit dated 10.05.1983 as served upon the O.P. by the Port Authority is valid, lawful and binding upon the parties and O.P.'s occupation, and that of any other occupant of the premises, has become unauthorised in view of Section 2(g) of the P.P Act
- 4) That O.P./any other person on behalf of O.P. have failed to make out any case in support of its occupation as "authorised occupation", inspite of sufficient chances being given.
- 5) That O.P. or any other person/s asserting any right through O.P. has failed to bear any witness or adduce any evidence in support of its occupation as "authorised occupation", inspite of sufficient chances being provided.
- 6) That O.P. is liable to pay damages for wrongful use and occupation of the Public Premises upto the date of handing over of clear, vacant and unencumbered possession to the Port Authority.



FINAL ORDER



The instant proceedings No. 612, 612/R and 612/D of 2004 arise out of the applications bearing No. Lnd 3798/II, Lnd 3798/II/04/1755 and Lnd 3798/II/20/2244 dated 04.07.1991, 13.09.2004 and 15.10.2020 respectively, filed by Syama Prasad Mookerjee Port, Kolkata [erstwhile Kolkata Port Trust/ KoPT, hereinafter referred to as 'SMP, Kolkata'], the applicant herein, under the provisions of the **Public Premises (Eviction of Unauthorised Occupants) Act, 1971** (hereinafter referred to as 'the Act') praying for an order of eviction and recovery of rental as well as compensation dues/mesne profit/ damages dues along with accrued interest in respect of the public premises, being the land measuring about 199.46 sq.m. situated as Hari Mohan Ghosh Road, Ramnagar, Thana: South Port Police Station, Kolkata (morefully described in the Schedule 'A' of the SMP, Kolkata's said application dated 04.07.1991) against **Shri Madhusudan Ghosh, son of Late Hiralal Ghosh**, (hereinafter referred to as **O.P.**).

The fact of the case in a nutshell is that the O.P. came into occupation of the said port property (under Plate Nos. D- 132/1) as a monthly term lessee. The allegations of SMP, Kolkata against the O.P are that the O.P defaulted in making payment of the rent and taxes, unauthorisedly parted with the possession of the premises to rank outsiders, who are occupying the premises by way of garage, hutment etc. in clear violation of the conditions of the lease in question. It is the case of SMP, Kolkata that the O.P. had failed and neglected to quit, vacate and deliver up peaceful possession of the premises in terms of the notice to quit dated 10.05.1983. It is the case of SMP, Kolkata that the tenancy with the O.P. was determined w.e.f. 01.07.1983 in terms of the Notice to Quit dated 10.05.1983 and the O.P. failed and neglected to vacate/ hand over the possession of the premises after service of the said Notice to Quit. SMP, Kolkata has made out a case that O.P. has no right to occupy the premises after the determination of tenancy in question upon service of a quit notice dated 10.05.1983.



This Forum of Law formed its opinion to proceed against the O.P. and issued 3 (three) nos. of Show Cause Notices upon the O.P. The first one was issued u/s 4 of the Act (for adjudication of the prayer of eviction) and the other two were issued u/s 7 of the Act (for adjudication of the prayer of arrear rent as well as arrear compensation/ damages/ mesne profit along with the accrued interest thereon etc.), all dated 24.12.2020 (vide Order No. 08 dated 24.12.2020), as per the Rules made under the Act.

The said Notices were sent through 'Speed Post' to the 2 (two) nos. of recorded addresses of O.P., viz., at 'J, 352A, Paharpur Road, Garden Reach, Kolkata- 700 024', and 'Hari Mohan Ghosh Road, Kolkata- 700 024'. One of such notices sent to 'J, 352A, Paharpur Road, Garden Reach, Kolkata- 700 024' returned undelivered by the Postal Department. However, the other notice sent to 'Hari Mohan Ghosh Road, Kolkata- 700 024' has not returned to this Forum raising a presumption of its due delivery to the addressee. The 'Process Server' attached with this Forum has submitted a report dated 22.02.2021 stating the notices could not be hand delivered as the premises was found to be in "door closed" condition. However, the Notices have been affixed in a conspicuous part of the property under schedule for a notice to all concerned, as per the mandate of the Act. However, on the day fixed for Show Cause by the O.P., viz. on 15.01.2021, neither the O.P. nor any person interested in the property has appeared before this Forum. Following the principles of natural justice that no one should be condemned unheard ('Audi Alteram Partem'), chance was given to the O.P. to represent their case. However, such effort remained infructuous as neither the O.P. nor anyone interested in the property made a contact or approached the Forum in connection with the Show Cause Notice issued by this Forum thereafter. A decision was then taken to publish a notice in a widely circulated newspaper and in the official website of SMP, Kolkata for a notice to all concerned about the pendency of the instant proceeding, in order to provide an opportunity to the O.P. to appear before this Forum and to represent their case. Such notice was published in 'The Times of India (Kolkata edition)' on 21.02.2022 fixing the date for O.P.'s appearance, filing reply to Show

Cause etc. on 09.03.2022, but such effort too went in vain, as none appeared from O.P's side and the efforts remained ineffective. Considering the situation that the attendance of O.P. could not be procured by this Forum, at any point of time, inspite of the possible efforts being made, even after the publication of a Notice in an English daily and even thereafter, I am inclined to proceed ex-parte against the O.P.

It appears that SMP, Kolkata has filed copies of several communications of SMP, Kolkata written to the O.P., such as letters dated 25.01.1982, 15.12.1980, 18.11.1980 with request to O.P. to liquidate the dues mentioned therein. SMP, Kolkata has filed the copy of offer letter of SMP, Kolkata dated 28.12.1979 and the copy of acceptance letter of O.P. dated 06.06.1980 agreeing with the terms and conditions of the lease in question. SMP, Kolkata has also produced detailed Statements of Account dated 12.10.2020 (filed under the cover of SMP, Kolkata's application dated 15.10.2020) in respect of the premises in question. It appears from the said statements of accounts that no payment, whatsoever, was made by O.P. in respect of the premises for decades altogether. In my view, such Accounts /Statements maintained by a Statutory Authority/ SMP, Kolkata in its usual course of business, has a definite evidentiary value, unless challenged with fortified documents/evidences etc., ready to bear the test of legal scrutiny. SMP, Kolkata also filed photographs of the premises in question in support of their contentions of garage, hutments etc.

Hence, I may say that I have nothing to disbelieve the allegations levelled against the O.P. from the documents filed by the Port Authority and I am left with no other alternative but to issue the Order of Eviction against O.P., as prayed for on behalf of SMP, Kolkata, on the following grounds/reasons:-

- 1) That O.P. has failed to appear before this Forum and failed to file reply to the Show Cause Notice/s under the Act inspite of sufficient chances being given.

ACCORDINGLY, I sign the formal order of eviction u/s. 5 of the Act as per Rule made there-under, giving 15 days' time to O.P., and any person/s whoever may be in occupation, to vacate the premises. I make it clear that all person/s, whoever may be in occupation, are liable to be evicted by this order and the Port Authority is entitled to claim damages for unauthorized use and enjoyment of the property against O.P., in accordance with the canons of Law till the date of unencumbered recovery of possession of the same.

SMP, Kolkata is directed to submit a comprehensive status report of the Public Premises in question on inspection of the property after expiry of the 15 days as aforesaid, so that necessary action can be taken for execution of the order of eviction u/s 5 of the Act, as per Rule made under the Act.

During the course of hearing, I am given to understand by SMP, Kolkata that the rent as well as mesne profit/compensation/damages charged from time to time is based on the rates notified by the Tariff Authority for Major Ports (TAMP) in the Official Gazette, which is binding on all users of the port property and non-payment of dues by O.P. appears to be established. Hence, I have no bar to accept the claim of SMP, Kolkata on account of rent as well as damages/compensation/ mesne profit etc. I have nothing to disbelieve in respect of SMP, Kolkata's claim against O.P. as per the records maintained regularly in SMP, Kolkata's office in regular course of business.

It is my considered view that a sum of Rs. 4,806.74 (Rupees Four Thousand Eight Hundred Six and paise Seventy Four only) for the period from 01.01.1982 upto 30.06.1982 and Rs. 18,87,420.89 (Rupees Eighteen Lakhs Eighty Seven Thousand Four Hundred Twenty and paise Eighty Nine only) for the period from 01.07.1983 upto 30.09.2020 is due and recoverable from O.P. by Port Authority on account of compensation dues/damages/ mesne profit and O.P. must have to pay the rental dues to SMP, Kolkata on or before 06.04.2022.

Such dues shall also attract compound interest @ 6.30 % per annum, which is the current rate of interest as per the Interest Act, 1978 (as gathered from the official website of the State Bank of India) from the date of incurrence of liability, till the liquidation of the same, as per the adjustment of payments, if any made so far by O.P., in terms of SMP, Kolkata's books of accounts.

I sign the formal Orders u/s 7 of the Act accordingly.

I make it clear that SMP, Kolkata is entitled to claim damages against O.P. for unauthorized use and occupation of the public premises right upto the date of recovery of clear, vacant and unencumbered possession of the same in accordance with Law, and as such the liability of O.P. to pay damages extends beyond

30.09.2020 as well, till such time the possession of the premise continues to be under the unauthorized occupation with the O.P. SMP, Kolkata is directed to submit a statement comprising details of its calculation of damages after 30.09.2020, indicating therein, the details of the rate of such charges, and the period of the damages (i.e. till the date of taking over of possession) together with the basis on which such charges are claimed against O.P., for my consideration for the purpose of assessment of such damages as per Rule made under the Act.

I make it clear that in the event of failure on the part of O.P. to pay the amounts to SMP, Kolkata as aforesaid, Port Authority is entitled to proceed further for recovery of its claim in accordance with law.

All concerned are directed to act accordingly.
