WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that Shri Salauddin & Anr, Quarters No.2, Block No 39, Hide Road Mazdoor Line, P.S.: S.P.P.S, Kolkata-700043 is in unauthorized occupation of the Public Premises specified in the Schedule below:

REASONS

- 1. That nothing has been shown in support of either O.P's occupation into the public premises.
- 2. That no evidence has been laid to support the possession of either O.P. as "authorized possession/occupation".
- 3. That mere occupation into the quarters for a period without any authority for such occupation cannot create any right over the property in question.

NOW, THEREFORE, in exercise of the powers conferred on me under Sub-Section (1) of Section 5 of the Public Premises (Eviction of Unauthorized Occupants) Act, 1971, I hereby order the said Shri Salauddin & Anr, Quarters No.2, Block No 39, Hide Road Mazdoor Line, P.S.: S.P.P.S, Kolkata-700043 and all persons who may be in occupation of the said premises or any part thereof to vacate the said premises within 15 days of the date of publication of this order. In the event of refusal or failure to comply with this order within the period specified above the said Shri Salauddin & Anr, Quarters No.2, Block No 39, Hide Road Mazdoor Line, P.S.: S.P.P.S, Kolkata-700043 and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

FINAL ORDER

The matter is taken up today for final disposal. It is the case of Syama Prasad Mookerjee Port, Kolkata [erstwhile Kolkata Port Trust], hereinafter referred to as SMP, Kolkata, Applicant herein, that Quarter No.2, Block No. 39 at Hide Road Mazdoor Line, P.S. West Port Police Station, Kolkata-700043 was allotted as per Rules governing the Commissioners(Trustees) Residential Accommodation for Class-IV Employees in favour of Shri Md. Mobin, Khalasi, who was employed with Superintendent, NSD-GRJ Section of Traffic Department w.e.f 08.03.1985. Thereafter the service allottee retired from SMP, Kolkata's 01.09.1987 and since then allotment stood cancelled. However, One Shri Salauddin(hereinafter referred to as O.P. No. 1), rank outsider, thereafter came to reside in the said Quarter with his family members forcibly on and from 01.09.1987 in an unauthorized manner and since then the O.P. No 1 was living unauthorisedly in the said quarter/ public premises as an unauthorised occupant. It is further the case of SMPK that on a recent inspection it has been said quarter is presently being that the unauthorisedly occupied by one Md. Jahangir Khan (hereinafter referred to as O.P. No. 2), who is also a rank outsider into the quarter/public premises in question.

This Forum formed its opinion to proceed against both O.P. No 1 and 2 by issuing the Show Cause Notice dated 22.02.2021 (vide Order no 04 dated 22.02.2021) for adjudication of the prayer of eviction, under the relevant provisions of Public Premises (Eviction of Unauthorized Occupants) Act, 1971 (hereinafter referred to as 'the Act') and the Rules made thereunder. The O.P. no 1 & 2 were called upon as per the relevant provisions of the Act and the Rules made thereunder to appear before this forum in person or through authorized representative/s, capable to answer all material questions connected with the matter, along with the evidence which the O.P.s intends to produce in support of their case.

The said Notice was sent through 'Speed Post'/hand delivery to the Quarter address of the O.P., and the same was not returned back to Forum. However, the 'Process Server' attached with this Forum has submitted his report dated 08.04.2021 intimating that such Notice was affixed on the property in question, as per the mandate of the Act. Inspite of such efforts made, the appearance of O.P. could not be procured and the efforts remained futile. Following the principles of natural justice, further attempt was made to serve such notice in terms of Order dated 10.05.2021. However, inspite of such efforts, nobody appeared before me with any authority to stay into the quarters in question. Considered the report of the Process Server dated 08.04.2021 and 26.07.2021 regarding affixation of Show Cause Notice u/s 4 of the Act on the property in question. I am satisfied with the service of notice to all concerned. No reply to the Show Cause Notice u/s 4 of the Act dated 22.02.2021 on behalf of either O.P. no 1 or O.P. no 2 has been filed. As such, I have nothing to disbelieve the statements made against both the O.P.s by the Port Authority. In fact, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority on the following grounds/reasons.

- That nothing has been shown in support of either O.P's occupation into the public premises.
- 2. That no evidence has been laid to support the possession of either O.P. as "authorized possession/occupation".
- 3. That mere occupation into the quarters for a period without any authority for such occupation cannot create any right over the property in question.
- 4. That both the O.P's occupation is unauthorized in all respect and both the O.P's have failed to make out any case in support of their occupation.
