
WHEREAS I, the undersigned, am satisfied that you were in unauthorised occupation of the public premises mentioned in the Schedule below:

FINAL ORDER

The instant proceedings No. 737/D of 2005 arises out of the application bearing No. Lnd.14/21/II/13/1787 dated 26.08.2013 read with an application bearing No. Lnd.14/21/II/21/4357 dated 24.12.2021 filed by the Syama Prasad Mookerjee Port, Kolkata [erstwhile Kolkata Port Trust, hereinafter referred to as 'SMP, Kolkata'], the applicant herein, praying for an order of recovery of dues and other charges etc. along with accrued interest in respect of the subject public premises, against M/s National Petroleum Company, (hereinafter referred to as O.P.), under relevant provisions of Public Premises (Eviction of Unauthorized Occupants) Act, 1971 (hereinafter referred to as 'the Act').

The fact of the case in a nutshell is that the O.P. came into occupation of the port property being land measuring about 126.25 sq.m situated at Cossipore on the west side of Strand Bank Road, Kolkata, comprised under occupation Plate Nos. SB-488/A, on monthly term lease basis. Thereafter, for the purpose of implementation of SMP, Kolkata's land use plan, Notice to quit was issued by SMP, Kolkata to O.P. on 16.04.2003. Thereafter, proceeding was initiated by SMP, Kolkata before this Forum against the O.P. under relevant provisions of the Act, which was numbered as Proceeding No. 737, 737/R of 2005. The O.P. appeared before this Forum and contested the case. Thereafter, the Final Order of eviction against the O.P. was passed on 27.06.2006. It appears that thereafter SMP, Kolkata vide their applications dated 26.08.2013 has intimated that the possession of the subject premises was taken over by the O.P. on 08.10.2007 in terms of the said Order of eviction dated 27.06.2006. It has also been intimated by SMP, Kolkata vide the said applications as referred above that considerable amount
