

FINAL ORDER

The matter is taken up today for final disposal. It is the case of Syama Prasad Mookerjee Port, Kolkata [erstwhile Kolkata Port Trust], hereinafter referred to as SMP, Kolkata, Applicant herein, that Quarter No.05, Block No. C at K.F. Shipping, P.S. South Port Police Station, Kolkata-700023 was under the lock and key of SMP, Kolkata since 06.03.1995. However, one Sri Imauddin(hereinafter referred to as O.P. No. 1), rank outsider forcibly occupied said Quarter by breaking open SMPK's padlock on or about 02.07.1999 and since then the O.P. No 1 was living unauthorisedly in the said quarter/ public premises as an unauthorised occupant. It is further the case of SMPK that on a recent inspection it has been found that the said quarter is presently being unauthorisedly occupied by one Sri Norshed Alam (hereinafter referred to as O.P. No. 2), who is also a rank outsider into the quarter/public premises in question.

This Forum formed its opinion to proceed against both O.P. No 1 and 2 by issuing the Show Cause Notice dated 22.02.2021 (vide Order no 04 dated 22.02.2021) for adjudication of the prayer of eviction, under the relevant provisions of Public Premises (Eviction of Unauthorized Occupants) Act, 1971 (hereinafter referred to as 'the Act') and the Rules made thereunder. The O.P. no 1 & 2 were called upon as per the relevant provisions of the Act and the Rules made thereunder to appear before this forum in person or through authorized representative/s, capable to answer all material questions connected with the matter, along with the evidence which the O.P.s intend to produce in support of their case.

The said Notice was sent through 'Speed Post' to the Quarter address of the O.P., however, the notice was returned undelivered by the Postal Department. The Process Server' attached with this Forum has submitted his report dated 24.03.2021 intimating that the service of the

ESTATE OFFICEN SYAMA PRASAD MOOKERJEE PORT notice has not been effected personally upon Opposite Parties both by hand delivery and affixation as the parties did not allow him to enter into the premises and threatened to assault him in case he makes further attempt to visit there. Thereafter, following the principles of natural justice, further attempt was made by the Forum to serve such notice upon the Opposite Parties by way hand delivery but such effort was further went into vain. The Report of the Process Server dated 26.07.2021 depicts that said Order was not served upon the O.P. due to O.P's refusal. Thereafter, finding no other option, Forum made another attempt by serving through Speed Post for procuring the attendance of O.P's in terms of Order dated 10.03.2022. However, such Postal communications sent to Opposite Parties were again returned undelivered to the Forum.

Inspite of such efforts, as nobody appeared before me with any authority to stay into the quarters in question and no reply to the Show Cause Notice u/s 4 of the Act dated 22.02.2021 on behalf of either O.P. no 1 or O.P. no 2 has been filed yet, I have nothing to disbelieve the statements made against both the O.P.s by the Port Authority. In fact, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority on the following grounds/reasons.

- That nothing has been shown in support of either
