आई. एंड सी. एफ. प्रभाग, हल्दिया गोदी परिसर, श्यामा प्रसाद मुखर्जी पोर्ट, कोलकाता के तहत वरिष्ठ उप प्रबंधक का एक पद, ₹ 80,000 - 2,20,000/- (पूर्व संशोधित ₹ 32,900 - 58,000/-) के वेतनमान में, 01 अक्टूबर 2022 से रिक्त होने वाली।

2. आई. एंड सी. एफ. प्रभाग, हल्दिया गोदी परिसर, एस. एम. पी., कोलकाता के तहत वरिष्ठ उप प्रबंधक का पद ₹80,000 - 2,20,000/- (पूर्व संशोधित ₹ 32,900 - 58,000/-) के वेतनमान में, सामासिक विधि से समावेशन द्वारा **एनेकक्षर-I** में संलग्न संबंधित पद के लिए भर्ती नियमों में निर्धारित योग्यता मानदंड को पूरा करने वाले प्रमुख पोर्ट के अधिकारियों से भरा जाना है। तथापि, रिक्ति को वास्तविक रूप से मंत्रालय की सहमति / अनुमोदन पर भरा जाएगा।

3. चयन योग्यता के आधार पर होता है जिसके लिए एसीआर / एपीएआर में समग्र ग्रेडिंग में बेंचमार्क "वेरी गुड" से नीचे नहीं होगा।

7. दिनांक 11.08.2021 के मंत्रालय के डेप्युटी एचओडी स्तर के पद को भरने के संबंध में परामर्श / निर्देश अनुसार, किसी भी आवेदक के संबंध में पोर्ट द्वारा आवेदन की अग्रिम प्रति प्राप्त होने की स्थिति में, आवेदक की उम्मीदवारी पर विचार नहीं किया जाएगा यदि आवेदन प्राप्त होने की अंतिम तिथि के 15 दिनों के भीतर उसका आवेदन-पत्र प्राप्त नहीं होता है।

Sub.: Filling up of the post of Senior Deputy Manager (I&CF) by absorption through composite method under Haldia Dock Complex, SMP, Kolkata.

One vacancy of Senior Deputy Manager under Infrastructure and Civic Facilities (I&CF) Division, Haldia Dock Complex, Syama Prasad Mookerjee Port, Kolkata, in the scale of pay of Rs. 80,000 – 2,20,000/- (Pre-revised Rs. 32,900 – 58,000/-) would arise w.e.f. October 01, 2022.

2. The post of Senior Deputy Manager under I&CF Division, Haldia Dock Complex, SMP, Kolkata in the pay scale of Rs. 80,000 – 2,20,000/- (Pre-revised Rs. 32,900 – 58,000/-) is to be filled up by Absorption through Composite Method, from the officers of Major Ports, fulfilling the eligibility criteria prescribed in the Recruitment Rules for the concerned post enclosed at **Annexure-I**. However, actual filling up of the vacancy will be done upon concurrence / approval of the Ministry.

3. The selection is by merit for which overall grading in the ACRs / APARs will not be below "Very Good".

4. Application of eligible and willing officers, who satisfy the provisions of the Recruitment Rules for the post of Sr. Dy. Manager under I&CF Division, HDC, may please be forwarded as per proforma enclosed (**Annexure-II**), alongwith the following documents, duly superscribing the envelope as "*Application for the post of Sr. Dy. Manager under I&CF Division, HDC, SMP-K*", so as to reach the office of undersigned on or before **August 04, 2022**.

- i) Copies of APARs for the last 5 years (2016 – 17 to 2020 - 21), attested by an officer not below the rank of Dy. HOD on each of the pages. [If APAR for a particular year is not available, last available APAR may be furnished, with a non-availability certificate.]
- ii) Attested photocopies of all certificates and proof of educational qualification, present and past work experience in the respective post and pay scale.
- iii) No objection certificate from the respective Port to relieve the applicant in the event of his / her selection.
- iv) Undertaking of the applicant to the effect that the candidature will not be withdrawn, if selected by the Service Selection Committee.

- v) Vigilance and administrative clearance of the concerned Port, as per enclosed proforma (**Annexure-III**).
- vi) Two passport size photographs.
- vii) Complete service details of the applicant with posts held till date.
5. The crucial date for determining eligibility will be **October 01, 2022**.
6. If any major or minor penalty has been imposed on the applicant during the last 10 years, the disciplinary case leading to such penalty alongwith necessary documents may be sent by the forwarding authority alongwith the application. Vigilance report is to be furnished in the format prescribed vide Ministry of Ports, Shipping and Waterway's Letter No. C-31018/5/2020-Vigilance dated February 15, 2022 (**Annexure – IV**).
7. As per Ministry's advisory / instructions dated 11.8.2021 in respect of filling up the post of Dy. HoD level, in case of receipt of advance copy of the application by the Port in respect of any applicant, candidature of the applicant would not be considered by the Port if his / her application is not received within 15 days of the last date of receipt of application.
8. Also, as per the aforesaid instruction dated 11.08.2021, the port official, who withdraws his candidature for the post after his her selection by the Service Selection Committee, will be liable for debarment from future selection to Dy. HoD level post in all Major Ports for a period of two years.
9. The Ports are required to forward the application of the applicants with the requisite documents on or before the date of closing i.e. **August 04, 2022**. In case of receipt of advance copy of application in respect of any applicant, candidature of the candidate will not be considered by HDC, SMP, Kolkata if the application is not received through proper channel by HDC, SMP, Kolkata within **15 days** of the last date of receipt of application i.e. **August 19, 2022**. Incomplete application or application received after the due date may not be considered.
