PREMISES (EVICTION OF UNAUTHORISED OCCUPANTS) ACT, 1971**


WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that Sri. Imtahan, Qrs. No. 17, Block No. B, K.F. Shipping, P.S. : SPPS, Kolkata - 700 023 is in unauthorized occupation of the Public Premises specified in the Schedule below :

REASONS

- 1) That no reply to the Show Cause notice is filed by O.P.s.
- 2) That nothing has been shown in support of O.P.s' occupation into the public premises.
- 3) That no evidence has been laid to support the possession of O.P.s as "authorized possession/ occupation".
- 4) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question.
- 5) That O.P.s' occupation is unauthorized in all respect and O.P has failed to make out any case in support of his occupation.

In the event of refusal or failure to comply with this order within the period specified above the said **Sri. Imtihan, Qrs. No. 17, Block No. B, K.F. Shipping, P.S. : SPPS, Kolkata - 700 023** and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.





FINAL ORDER

The matter is taken up today for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust) applicant, herein, that all along SMP,K is the owner of the of Quarter No. 17 Bl. No. B at K.F. Shipping Mazdoor Line. The said quarter was under lock and key since 08.10.1985. On or about 01.07.1999, Sri Imtahaan, the Opposite Party, hereinafter referred to as O.P. forcibly occupied the above quarters by breaking open the padlock. SMPK filed an application dated 12.01.2000 praying for an order of eviction against O.P. I am appalled by the fact that since then almost 22 years have elapsed and the matter was never placed before any Estate Officer for proper adjudication thereby frustrating the entire spirit of the Act of 1971. Since then O.P. had been unauthorisedly occupying the said quarters without any authority. SMP,K vide application dated 04.01.2021 submitted that on a recent inspection it was found that the subject quarter is presently being unauthorisedly occupied by one Tar Mohammad, another rank outsider.

This Forum on having the information of such unauthorised occupation issued a Notice to Show Cause under Section 4 of the Public Premises (Eviction of Unauthorised Occupant) Act, 1971 (hereinafter referred to as The Act) on 18.01.2021. The said Show Cause notice along with the order dated 18.01.2021 were sent through "Speed Post", however the envelope was returned back with the remark "Insufficient Address". The Show Cause notice along with the order were also sent through Process Server. It is seen from the report of the Process Server dated 03.02.2021 that the order dated 18.01.2021 was received by one Md. Siraj on 03.02.2021 at 3 p.m. It is further seen from the Report of the Process Server that due affixation of the order along with the Show Cause notice were made on a conspicuous part of the premises for notice to all concerned. Order dated 15.02.2022 was also sent through Process Server. It is seen from the report of the Process Server dated 01.04.2021 that "the party refused take the order" as well as did not allow the order to be affixed on the subject premises. I am satisfied with the service of notice.

In course of hearing inspite of having knowledge of the pending proceedings neither O.P. nor anyone interested in the said property appeared before the Forum to place their submissions. No Reply to the Show Cause Notice has been filed by O.P. or any other person interested on the property. In view of the above, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have no reason to disbelief on the statements made by SMPK before the Forum. Accordingly the order of eviction is issued on the following grounds/ reasons;

- (a) That no Reply to the Show Cause has been filed by O.P.s or anyone else
- (b) That nothing has been shown in support of O.P.s' occupation into the premises;
- (c) That no evidence has been laid to support the possession of O.P.s as "authorised possession/occupation"
- (d) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question;
- (e) That O.P.s' occupation is unauthorised in all respect and O.P.s' have failed to make out any case in support of his occupation.

Accordingly, Department is directed to draw up a formal order of eviction u/s5 of the Act and Rules made thereunder against O.P., giving 15 days time to all the occupants of the quarters in question or whoever may be in occupation are liable to be evicted by this Order and SMP,K is entitled to claim damages for unauthorised use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.
