WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that Sri. Jamal Qtrs. 7 Block No. 39 at Hide Road Mazdoor Line P.S. S.P.P.S. Kolkata- 700 043 is in unauthorized occupation of the Public Premises specified in the Schedule below:

REASONS

1) That no reply to the Show Cause notice is filed by O.P.

Kolkata- 700 043 and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

FINAL ORDER

The matter is taken up today for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust) applicant, herein, that all along SMP,K is the owner of the of Quarter No. 7 Bl. No. 39 at Hide Road Mazdoor Line. The said quarter was under lock and key since 23.11.2001. On or about 20.03.2002, Shri Jamal, the Opposite Party, hereinafter referred to as O.P. forcibly occupied the above quarters by breaking open the padlock. Since then O.P. had been unauthorisedly occupying the said quarters without any authority. SMPK filed an application dated 22.04.2002 praying for an order of eviction against O.P. I am appalled by the fact that since then almost 20 years have elapsed and the matter was never placed before any Estate Officer for proper adjudication thereby frustrating the entire spirit of the Act of 1971. SMP,K vide application dated 04.04.2022 submitted that on a recent inspection it was found that the subject quarter is presently being unauthorisedly occupied by one Sri Javed.

This Forum on having the information of such unauthorised occupation issued a Notice to Show Cause under Section 4 of the Public Premises (Eviction of Unauthosied Occupant) Act, 1971 (hereinafter referred to as The Act) on 27.05.2022. The said Show Cause notice along with the order dated 27.05.2022 were sent through
