

Sub.: Filling up of the post of Diving Officer in the scale of pay of ₹40,000-1,40,000/- under Marine Operations Division of Haldia Dock Complex, Syama Prasad Mookerjee Port, Kolkata by absorption.

One anticipated vacancy in the post of Diving Officer under Marine Operations Division of Haldia Dock Complex, Syama Prasad Mookerjee Port, Kolkata, in the pay scale of ₹40,000-1,40,000/- is to be filled up by absorption, from the officers holding analogous posts in a Major Port Trust, fulfilling the eligibility criteria prescribed in the Recruitment Rules for the concerned post, as per the enclosed Schedule of the KoPT Employees' (Recruitment, Seniority and Promotion) Regulations, 2013 (Annexure-I).

- 2. Application of suitable and willing officers, who satisfy the provisions of the Recruitment Rules for the post of Diving Officer under Marine Operations Division, may please be forwarded as per proforma enclosed (Annexure II), along with the following documents, duly superscribing the envelope as "Application for the post of Diving Officer under Marine Operations Division, HDC", so as to reach the office of Sr. Dy. Manager (P&IR) on or before February 23, 2023.
  - Copies of APARs for the last 5 years, attested by officer not below the rank of Dy. HOD
    on each page. [If APAR for a particular year is not available, last available APAR may be
    furnished with a non-availability certificate.]
  - ii) Attested photocopies of all certificates and proof of educational qualification, present and past work experience in the respective post and pay scale.
  - iii) No objection certificate from the respective Port.
  - iv) Undertaking of the applicant to the effect that the candidature will not be withdrawn, if selected.
  - Vigilance and administrative clearance of the concerned Port, as per enclosed proforma (Annexure-III).

- vi) Two passport size photographs.
- vii) Complete service details of the applicant with posts held till date.
- 4. The selection is by merit for which the benchmark in overall grading in the ACRs / APARs will not be below "Good".
- 5. The Crucial date of determining eligibility will be February 01, 2023.
- 6. If any major or minor penalty has been imposed on the applicant during the last 10 years, the disciplinary case leading to such penalty alongwith necessary documents may be sent by the forwarding authority alongwith the application. Vigilance report is to be furnished in the format prescribed, vide Ministry of Ports, Shipping and Waterways's Letter No. C-31018/5/2020-Vigilance dated February 15, 2022 (Annexure-IV).
- 7. The Ports are required to forward the application of the applicants with the requisite documents on or before the date of closing i.e. February 23, 2023. In case of receipt of advance copy of application in respect of any applicant, candidature of the candidate will not be considered by HDC, SMP-K if the application is not received through proper channel by HDC, SMP-K within 15 days of the last date of receipt of application i.e. March 10, 2023. Incomplete application or application received after the due date will not be considered.

The authority forwarding the application is requested to verify that the application is in order. Application received without the forwarding authority's certificate, as prescribed in the enclosed proforma, will not be considered.
