WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that

- 5) That O.P.s' occupation is unauthorized in all respect and O.P has failed to make out any case in support of his occupation.



NOW, THEREFORE, in exercise of the powers conferred on me under Sub-Section (1) of Section 5 of the Public Premises (Eviction of Unauthorized Occupants) Act, 1971, I hereby order the said **Shri G.K. Jadav & Ramajay Singh, Qtrs. 13 Block No. 37 at Hide Road P.S. South Port Police Station. Kolkata- 700 043** and all persons who may be in occupation of the said premises or any part thereof to vacate the said premises within 15 days of the date of publication of this order. In the event of refusal or failure to comply with this order within the period specified above the said **Shri G.K. Jadav & Ramajay Singh, Qtrs. 13 Block No. 37 at Hide Road P.S. South Port Police Station. Kolkata- 700 043** and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.

FINAL ORDER

The matter is taken up today for final disposal. Relevant facts are required to be put forward in a nutshell in order to understand the chain of events leading to the proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata hereinafter referred to as SMP,K, (erstwhile Kolkata Port Trust) applicant, herein, that all along SMP,K is the owner of the of Quarter No 13 Block no.37 at Hide Road Mazdoor Line . The said quarter was under lock and key since 18.09.2002. On or about 03.10.2002, one Sri G.K. Jadav, the Opposite Party No. 1 hereinafter referred to as O.P. No.1 forcibly occupied the above quarters by breaking open the padlock and has since been living in the quarters unauthorisedly. An application was filed by SMPK on 25.10.2002, praying for eviction of O.P. No. 1. Upon a query being made by the Forum on 15.02.2022, an application was filed by SMPK on 12.08.2022, stating that the quarters in question is still under the unauthorised occupation of one Ramajay Singh, rank outsider hereinafter referred to as O.P. No. 2.

This Forum on having the information of such unauthorised occupation issued a Notice to Show Cause under Section 4 of the Public Premises (Eviction of Unauthorised Occupant) Act, 1971 (hereinafter referred to as The Act) on 09.05.2022. The said Show Cause notice along with the order dated 12.10.2022 were sent through "Speed Post". The envelope, was returned with the remark "No such person in the address". The said order was also sent through Process Server. It is seen from the report of the Process Server dated 17.10.2022, that the door of the

subject quarters was found closed. However, due affixation was also made in the conspicuous part of the premises for notice to all concerned. As the matter could not be taken up for hearing on the fixed date another order was passed by the Forum on 26.10.2022, re-fixing the matter for hearing. The said order was also sent through Speed Post. It is seen that the envelope has been returned by the postal department with the remark "no such person the address". The said order was also sent through Process Server. It is seen from the report of the Process Server dated 03.11.2022, that the door of the subject quarters was found closed. However, due affixation of the order was made on a conspicuous part of the premises. I am satisfied with the service of notice.

In course of hearing inspite of having knowledge of the pending proceedings neither O.P. nor anyone interested in the said property appeared before the Forum to place their submissions. No Reply to the Show Cause Notice has been filed by O.P. or any other person interested on the property. In view of the above, I am left with no other alternative but to issue order of eviction as prayed for on behalf of the Port Authority. I have no reason to disbelief on the statements made by SMP,K before the Forum. Accordingly the order of eviction is issued on the following grounds/ reasons;

(c) That no evidence has been laid to support the possession of O.P. as "authorised possession/occupation"

(d) That mere occupation into the quarters for a certain period without any authority for such occupation cannot create any right over the property in question;

(e) That O.P.'s occupation is unauthorised in all respect and O.P. has failed to make out any case in support of his occupation.

Accordingly, Department is directed to draw up a formal order of eviction u/s5 of the Act and Rules made thereunder against O.P., giving 15 days time to all the occupants of the quarters in question or whoever may be in occupation are liable to be evicted by this Order and SMP,K is entitled to claim damages for unauthorised use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.
