- (iii) Details of the Ministry/Dept. and post/s held during the service etc.
- (iv) 2 recent passport size photographs.
- (v) Photo identity card issued by the Govt. of India (Aadhar Card/Passport etc.).

## TERMS AND CONDITIONS FOR ENGAGEMENT/EMPANELMENT IN SYAMA PRASAD MOOKERJEE PORT, KOLKATA (SMPK)

- 1. A lump sum amount of Rs. 75,000/- will be payable for per completed case upon submission of final Inquiry Report to the Disciplinary Authority.
- 2. An advance of Rs. 15,000/- (i.e. 20% of the total amount) may also be payable upon initiation/allotment of each departmental inquiry, to enable the selected candidate to meet daily ancillary personal expenses, which will be adjusted against final payment upon completion and submission of inquiry report to the Disciplinary Authority.
- 3. To and fro transport from residence to the office will be provided by SMP, Kolkata on the days of inquiry related job including days of hearing.
- 4. For conducting departmental inquiry, an office space will be provided, preferably at Subhash Bhawan, 40, CGR Road, Kolkata–700023, along with a stenographic assistance, as per your requirement.
- 5. The engagement/empanelment shall remain valid initially for a period of two years, which may be extended for a period of further one year.
- 6. The selected candidate will maintain strict secrecy and confidentiality in respect of documents/information/data to be deposited with him/her for the purpose of inquiry. No such information/documents/data should be divulged to anybody during the inquiry and after completion of the inquiry proceedings.
- 7. The selected candidate will not engage himself/herself in any other professional work or services which is likely to interfere with the performance of his/her duty as IO.
