

## ADDENDUM - 2

With reference to e-tender nos. MSTC/HO/KOLKATA PORT TRUST/20/KOLKATA/18-19/8888, MSTC/HO/KOLKATA PORT TRUST/19/KOLKATA/18-19/8887 & MSTC/HO/KOLKATA PORT TRUST/21/KOLKATA/18-19/8889 bearing NIT Nos. KoPT/KDS/TFC/03-2018, KoPT/KDS/TFC/04-2018 & KoPT/KDS/TFC/03-2018 respectively, following information may be noted:-

**1. Clause no 12 (a) in Annexure-IV of the tender document should be read as**

Failing amicable settlement, the dispute or differences or claims as the case may be, shall be finally settled by binding arbitration under the Arbitration and Conciliation Act, 1996 **as amended from time to time thereafter**. The arbitration shall be by a panel of three Arbitrators, one to be appointed by each party and the third to be appointed by two arbitrators appointed by the parties. A party requiring arbitration shall appoint an Arbitrator in writing, inform the other party about such appointment and call upon the other party to appoint its Arbitrators within 60 days. If the other party fails to appoint its Arbitrators, the party appointing Arbitrator shall take steps in accordance with Arbitration and Conciliation Act, 1996.

### Instead of

Failing amicable settlement, the dispute or differences or claims as the case may be, shall be finally settled by binding arbitration under the Arbitration and Conciliation Act, 1996. The arbitration shall be by a panel of three Arbitrators, one to be appointed by each party and the third to be appointed by two arbitrators appointed by the parties. A party requiring arbitration shall appoint an Arbitrator in writing, inform the other party about such appointment and call upon the other party to appoint its Arbitrators within 60 days. If the other party fails to appoint its Arbitrators, the party appointing Arbitrator shall take steps in accordance with Arbitration and Conciliation Act, 1996.
